was present to provide an update on Gateway

Academy/Breathitt Center Renovations and Additions. Mr. Owens updated the board on the work completed and what work is in progress and stated that the project is on schedule.

NURSES REPORT 3rd NINE WEEKS

Ms. Megan Kidd, Head Nurse, provided the 3rd nine weeks' nurses' report for the Board noting that 22,462 students had visited the nurses in the schools the 3rd nine weeks of the 2018-19 school year (a copy of which is attached and the terms of which are incorporated by reference.)

TRANSPORTATION UPDATE

Mr. Mike Brumley, Director of Transportation, was present to give the board an update on the Transportation Department.

He began the update with the sad news that one of his drivers died unexpectedly last week, giving condolences to her family.

Mr. Brumley stated he has a total of 96 bus routes, which is a decrease from 114 routes in the 2011-2012 school year. Those decreased routes were accomplished by redistricting. Mr. Brumley stated the department has enrolled 27 new drivers and of those 27 people, 18 passed the test and 16 are currently employed as bus drivers by the district. He stated when school is out on May 23, they will have traveled approximately two million miles this school year with no serious student injuries.

Mr. Brumley stated their full time payroll clerk retired this year after 27 years and they replaced the position with a 3 day per week part time employee for a savings of approximately \$25,000 per year. Mr. Brumley stated that total expenditures are down about \$100,000 to date and that is due to better pricing on items and working more efficiently. He stated their clean burn heating during the winter continues to save the department approximately \$15,000-\$18,000 per year. The fall 2017 conversion of a shop to a wash and paint bay has already saved the district \$80,000 in body repair to buses as they are making those repairs in house now.

Mr. Brumley stated he has researched the benefits of the district purchasing propane buses due to the savings it would allow in fuel. After reviewing all components (size of bus, fueling

unit, bus repairs, etc.) he feels it would not be in the best interest of the district to purchase propane buses at this time but is open to any suggestions the board may have.

INSTRUCTIONAL UPDATE: DIAGNOSTIC REVIEW RESULTS

Mary Ann Gemmill, Superintendent, was present to give the board an update on the Diagnostic Review Results of Freedom Elementary School and Martin Luther King, Jr. Elementary School.

Ms. Gemmill stated the district received the Diagnostic Review results from Kentucky Department of Education last week and the district now has 30 days to write an action plan in response to the feedback for improvement. Ms. Gemmill stated KDE found that both principals have great capacity to lead their schools and district leadership has great capacity to work with both schools through a school improvement process. She stated one school had two improvement priorities and one school had three priorities. The district will own all those priorities and work with the schools to improve upon them. Ms. Gemmill stated they are already working on an action plan for improvement and will roll that out at the May board meeting. She also stated each school will be given \$230,000 to assist on the improvement of student achievement.

COMMITTEE REPORTS

Mr. Clark

Mr. Clark stated he spoke with State Representative Dossett before the meeting and they talked about funding issues with public schools. Mr. Clark brought up the fact that regulations mandated by the State but are unfunded or very expensive for districts to afford. Mr. Dossett would like the district to sit down and make a list of such mandates that districts are struggling to fund so that he can review legislation regarding them.

Mr. Bell stated the Studer word of the month is Diversified. Mr. Bell stated the reason why diversity helps our school district is that it makes it a place that is open for different opinions and backgrounds. He stated most of all we do things together. Mr. Bell stated he is still a part of a book study "Revitalized Community" and some things in the book mirror Hopkinsville. He hopes to see some positive things happening in Hopkinsville.
