

The Woodford County Middle School Cheerleaders are requesting permission to travel to Orlando, Florida to compete in the 2020 Universal Cheerleaders Association (UCA) Cheerleading Championships, along with the World School Cheerleading Championships. We qualified for Worlds again this year by finishing 5th in the World this past season in Orlando. This competition is held the same weekend as UCA Nationals at the same venues. The most recent season we finished 2nd in GameDay Junior High by 0.1 and top 14th in the Nation at UCA Nationals in Orlando in 2 ½ minute Large Junior High. For Worlds, you must qualify the year before to attend.

I have had the privilege of coaching many cheerleaders over the years. Some come back wanting to volunteer, to watch the teams, to coach, or to keep in touch. I have had several cheerleaders and parents who when we see one another we talk about how cheer has helped them learn life skills that has been carried on from middle school cheer.

The cheerleaders are held accountable for their behavior not just at school but in the community and on social media. They have a handbook that we follow. Some students that have cheered have made better decisions after becoming cheerleaders. One student was having issues in behavior and after becoming a cheerleader those behavior issues declined significantly due to being held accountable within and out of the classroom. Another student could have went down two different paths; Her mom said she went down the best path because of cheerleading and was held accountable. Everyone's end of the seasons goals were to make it to Orlando and to be able to cheer on the biggest stage that they could. A lot of the cheerleaders when asked on 8th grade night their most memorable experience was going to Orlando and how they placed and the competition. To see them come together as a team and support each other is very rewarding as a coach and as a parent. This past season a cheerleader that normally does not compete was able to come in and compete for someone. Her mom has thanked me several times for her giving that opportunity and I say she earned it with hard work she can do anything. .She is trying out for the high school team and her mom said she would have never dreamed that she would have the confidence to try out for Middle School let alone for high school until she made the team and then she saw her blossom on the team this past year. When she went to Florida, even though she did not compete on the competition mat the support that she gave her teammates was incredible. A team is a team and each one of us support the other is what she told others; we win as a team we lose as a team. That is what we teach. There are some on the team that the only time that they have been to Orlando was with our team and they may not ever go back.

For our community, having the middle school cheerleaders represent Woodford County all the way to Florida is very important. People see Woodford County on our clothing all the time. If we go eat somewhere they ask where we're from and then they have a positive interaction with Woodford County cheerleaders. Every time we have traveled we have gotten compliments for how our kids act when we are out at competitions, eating or traveling together as a group from any place. We also have three different days that has been declared Woodford County cheer days over the last 3 years that we have been able to travel to Orlando and high placements in the competitions that we have been in.

I will re-submit the out-of-state request with the words that I left out of which day we would depart and which day we returned which is the same that we did last year. I always like to put in my request early

so I can communicate everything to the parents of the students on the team. I am very upfront and like to communicate with them as soon as I know something about competitions, schedules, look into charter bus or airplane costs, and local/not local competition so everyone has time to plan ahead and not miss things.
