ALLEN COUNTY DISTRICT FACILITIES PLAN HEARING REPORT

A public hearing was held at the Allen County Board of Education on April 15, 2019 at 5:30 PM CST (local time). The purpose of the public hearing was to propose a new District Facility Plan developed by the Allen County Local Planning Committee. The Local Planning Committee (LPC) voted 16 "for" and 0 "against" in favor of the proposed new plan and the Board voted 5 "for" and 0 "against" to approve the new plan. There were 0 number of persons at the hearing exclusive of the hearing officer. Kelly Grizzle, Facilities Director – Allen County, served as the locally-appointed hearing officer.

COMMENTS

Kelly Grizzle called the public hearing to order. Kelly Grizzle outlined the purpose of the hearing and the hearing procedures in accordance with 702 KAR 4:180. It was explained that those persons wishing to speak would be given the opportunity and that written statements would be accepted. All considerations will be made available to the Kentucky Board of Education via the hearing officer's report. Kelly Grizzle read the proposed new District Facility Plan which includes; renovation of the Allen County Learning Center, additional renovation to James E Bazzell Middle School that was not completed during the 2017 renovation, partial renovations to Allen County Intermediate Center, partial renovation to Allen County Primary Center, a district wide whiteboard initiative, a district wide security initiative, construction of a new bus garage and central storage building, and discretionary projects that include football fieldhouse renovation, ADA bleacher upgrade, construct a soccer field and a soccer complex, and mechanical systems of the Allen County Scottsville High School. The floor was opened to those who wished to make a statement. No statements were made.

RECOMMENDATIONS

It is recommended that the new District Facility Plan as developed by the Allen County Local Planning Committee and adopted by the Allen County Board of Education be approved as the District Facility Plan for the Allen County School District. A copy of the new plan is attached.
