Science Hill Independent SCHOOL DISTRICT **DISTRICT FACILITIES PLAN HEARING REPORT***

A public hearing was held at the **Science Hill Independent School Board Room** on **Tuesday, March 5, 2019**, at **6:00 p.m.** (local time). The purpose of the public hearing was to propose a new District Facility Plan developed by the **Science Hill Independent** Local Planning Committee. The Local Planning Committee (LPC) voted **all 9 (with Supt. Dyehouse being a non-voting member)** in favor of the proposed new plan and the Board voted **all 5 members in favor** to approve the new plan.

There was/were **(4) people at the hearing exclusive of the hearing officer** individual(s) in attendance: **Mr. Mark Catron, Board Member**, served as the locally-appointed hearing officer. **Superintendent Jimmy Dyehouse, LPC Member Bob VanBruggen, Architect Derek Phillips, and Facilitator Jessica Phillips** was/were present.

COMMENTS

Mr. Mark Catron, Hearing Officer, called the public hearing to order. The hearing officer outlined the purpose of the hearing and the hearing procedures in accordance with 702 KAR 4:180. It was explained that those persons wishing to speak would be given the opportunity and that written statements would be accepted. All considerations will be made available to the Kentucky Board of Education via the hearing officer's report. The hearing officer read the proposed new District Facility Plan which includes; **a major renovation to include roof replacement, HVAC replacement, a security vestibule, ADA and Life Safety upgrades, and the construction of a second entrance to the school to facilitate separation of bus and car traffic as Priority 1c. The plan includes a Major 30 Year Renovation as Priority 2c., which involves upgrades and replacements to the building elements that have reached life expectancy. Priority 2d. is a District SMART Board Initiative. Capital Construction Priority 4 projects include the construction of a Central Office and Central Bus Garage. Finally, Priority 5 projects involve playground replacements, purchase of property for athletic fields, and construction of athletic fields.**

The floor was opened to those who wished to make a statement. **No statements were made by the public.**
