

## **ORDINANCE 10-2019**

**AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR THE FISCAL YEAR BEGINNING JULY 1, 2018 AND ENDING JUNE 30, 2019, AND AMENDING ORDINANCE 9-2018 TO FUND THE BUDGET CONTINGENCY AND CORRECT PURCHASE ORDER ROLLOVERS IN THE GENERAL FUND; TO PROVIDE FOR PURCHASE OF ELEVEN (11) SETS OF BODY ARMOR FROM THE PROPERTY RECOVERY FUND; TO RECEIVE FEDERAL JUSTICE ASSISTANCE GRANT (JAG) FUNDS FOR PURCHASE OF BREATHALYZERS, TRAFFIC DATA COLLECTOR AND ACCIDENT RECON EQUIPMENT IN THE JAG GRANT FUND; AND TO PROVIDE FOR CONVENTION CENTER OPERATIONS.**

**WHEREAS**, the 2018-2019 Annual Budget was adopted by Ordinance 9-2018 on the 12<sup>th</sup> day of June, 2018; and

**WHEREAS**, a budget amendment for the City of Owensboro for the fiscal year beginning July 1, 2018, and ending June 30, 2019, has been prepared and is incorporated hereto by reference; and

**WHEREAS**, said budget amendment was submitted to the Board of Commissioners and examined by said Board; and

**WHEREAS**, KRS 91A.030 (1) requires the passage of an amended appropriation ordinance based on the budget amendments.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:**

**Section 1.** The 2018-2019 Annual Budget appropriation Ordinance 9-2018 is hereby amended in accordance with the revenue and appropriation budget amendments which are attached hereto and incorporated herein as if fully set forth in this Section 1.

**Section 2.** The Mayor, City Manager, Director of Finance and Support Services, City Attorney, and their designees as per applicable ordinance are hereby authorized to negotiate and execute all contracts, deeds, titles, purchase orders, agreements and other documents deemed necessary to facilitate the budget amendments contained herein.
