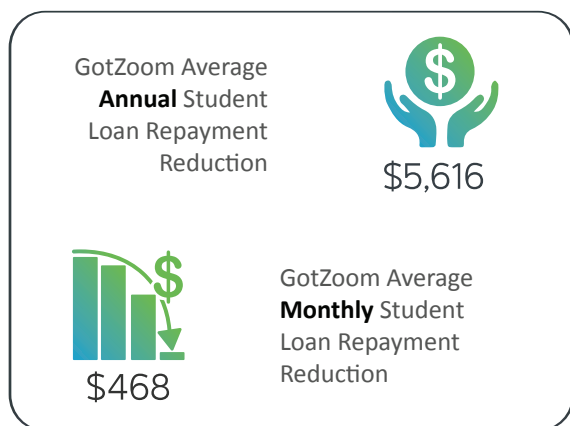

01 Employee Inputs

Employees start by completing the GotZoom enrollment web page

02 Benefit Analysis

- Reduced monthly loan payment,
- Shortened loan term,

03 DOE Program Enrollment
