Citizens are having a hard time finding help toward the cause even after having contacted surrounding counties, KY Division of Water, KY Conservation, and Army Corp of Engineers. 3rd District Magistrate Joe Barnes suggested helping by having county pull out large debris and the fire department control burning it.
