

ORDINANCE 14-2019

AN ORDINANCE DECLARING THE CITY OF OWENSBORO'S INTENT TO ANNEX INTO THE CITY CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 1622 SOUTHEASTERN PARKWAY, CONTAINING 6.370 ACRES, MORE OR LESS.

WHEREAS, the territory intended to be annexed, approximately 6.370 acres, located at 1622 Southeastern Parkway, is contiguous to the City of Owensboro; and

WHEREAS, the territory intended to be annexed is either urban in character or suitable for urban development without unreasonable delay because many of the residential and commercial lots in the area are in receipt of city services; and

WHEREAS, the proposed territory to be annexed is all situated within the County of Daviess, Kentucky and not within another incorporated city or in the process of being incorporated, nor within an agricultural district; and

WHEREAS, all the real property owners within the territory proposed to be annexed have not given their consent to be annexed; and

WHEREAS, The City declares it desirable to annex the approximately 6.370 acres, more or less, further described in this Ordinance and its attachment (Exhibit A).

NOW, THEREFORE, BE IT ORDAINED by the City of Owensboro, as follows:

Section 1. Pursuant to KRS 81A.420, the City of Owensboro hereby declares it desirable to annex and hereby publishes its intent to annex through the enactment of this Ordinance the territory described below and shown on the map attached to this Ordinance as Exhibit A. Exhibit A is incorporated into this Ordinance by reference as if copied in full.

A tract of land located on the east side of Owensboro, Daviess County, Kentucky more particularly described as follows:

Beginning at a point in the east right of way line of Southeastern Parkway, said point being the southwest corner of the parcel described herein; thence following the east right of way line of Southeastern Parkway and the new city limit line as follows: N 63°26'20" E, 65.85 feet to a point; thence N 63°33'00" E, 58.35 feet to a point; thence N 63°10'35" E, 52.78 feet to a point; thence N 62°10'55" E, 53.21 feet to a point; thence N 62°08'00" E, 95.42 feet to a point; thence N 56°42'35" E, 122.43 feet to a point; thence N 47°20'50" E, 56.60 feet to a point; thence N 40°48'05" E, 55.10 feet to a point; thence N 34°22'00" E, 55.77 feet to a point; thence N 26°26'50" E, 59.46 feet to a point; thence N 19°08'20" E, 56.67 feet to a point; thence N 13°44'15" E, 50.32 feet to a point; thence N 11°53'15" E, 42.88 feet to a point; thence N 13°48'20" E, 26.74 feet to a point; thence N 17°03'15" E, 47.41 feet to a point; thence N 23°22'25" E, 11.33 feet to a point being the northwest corner of the parcel described herein; thence leaving the east right of way line of Southeastern Parkway and following the new city limit line S 72°23'30" E, 269.30 feet to a point in the current city limit line; thence following the current city limit line and the east line of the parcel described herein with the following two calls: S 17°36'30" W, 217.84 feet to a point; thence S 18°41'55" W, 553.56 feet to a point being the southeast corner of the parcel described herein; thence following the current city limit line with the following two calls: N 71°34'10" W, 110.31 feet to a point; thence N 72°37'10" W, 233.62 feet to a point; thence leaving the current city limit line and following the new city limit line with the following two calls: N 72°28'45" W, 175.28 feet to a point; thence N 72°31'45" W, 115.63 feet to the point of beginning containing 6.370 Acres as shown on an Annexation Plat prepared by the City Engineer's office dated 05/07/2019

Section 2. All prior Municipal Orders or Ordinances or parts of any Municipal Order or Ordinance in conflict herewith are hereby repealed and the provisions of this Ordinance are hereby declared to be severable and, if any section, phrase or provision shall, for any ready, be declared invalid, such declaration of invalidity shall not affect the validity of the remainder of this Ordinance.


Section 3. This Ordinance is adopted pursuant to KRS 83A.060 in that it was introduced on May 21, 2019, and given final reading on June 4, 2019, and said Ordinance shall be in full force and effect upon signature, recordation and publication in accordance with KRS 81A.060 and KRS Chapter 424.




