- A. This grant may be used only for the PLTW Launch program. The products and services provided by this grant may be used only for the PLTW Launch program (the "Program"). Grantee must begin offering PLTW Launch modules in the 2019-2020 academic year. The products and services provided by the grant, which may consist of distributions, equipment, services and/or resources made available to the Grantee, to be determined in the sole but reasonable discretion of PLTW, will be used to offset the eligible PLTW Program implementation costs associated with the Program. The eligible PLTW Program implementation costs are the 2019-2020 PLTW program participation fee; Teacher training fees for up to two teachers to complete PLTW Launch Classroom Teacher Training; and PLTW Launch Module/Grade Level Kits valuing up to \$3,000. - B.
