Pursuant to KRS 160.560 and KAR 3:080, each local board of education is required to secure an official fidelity bond on the district Treasurer.


**SUMMARY OF MAJOR ELEMENTS:**

**Fidelity (Performance) Bond of Treasurer Form**

Of the Woodford County Board of Education

We, Amy Marie Smith (Treasurer, Finance Officer or Other), and the The Ohio Casualty Insurance Company, (Surety Company), do hereby acknowledge ourselves jointly and severally indebted to the Commonwealth of Kentucky in the penal sum of \$400,000.00, that Amy Marie Smith, (Treasurer, Finance Officer or Other) with the Board of Education, shall discharge the duties of said office according to law, account for, to the proper authorities, and pay over to all parties legally entitled thereto, on the proper vouchers only, any and all funds that may come into his/her hands as the (check the box)  Treasurer and/or  Finance Officer or  Other of the Board of Education aforesaid, beginning July 1, 2019 and to be renewed on an annual basis or until his/her successor is duly appointed and qualified. This bond can be terminated by the surety, upon written notice to the Department of Education and school board given by registered mail sixty (60) days in advance. The school board has the right of cancellation with this surety company/bond for any reason with a written 60 day notice to the surety company and the Department of Education.
