Mrs. Elizabeth Bird stated that the City of Henderson has gone above and beyond in working with her to get everything coordinated in such a short time. It was a nice collaborative effort.

VII.E. Employee Pay Options

Discussion:

Ms. Cindy Cloutier presented information that was requested at the last board meeting to calculate the cost of an optional day and the option to change from a monthly to a semimonthly pay schedule. Ms. Cloutier stated that one optional day would cost the District \$150,300. Ms. Cloutier presented the cost to move to semi-monthly pay, which would include adding a payroll clerk. Ms. Cloutier also stated that a survey was conducted of all employees regarding what their preference would be. With 58% of employee response, 65/35 in favor of going to two times per month. Mr. Mike Waller asked if the Superintendent has a recommendation. Mrs. Stanley said that the District would prefer still paying once a month and not to spend the additional \$30,000 for a clerk. However, Mrs. Stanley did state that we did get a good number of responses from staff and that would be a valid amount to move to semi-monthly pay. Mrs. Tracey Williams stated that it would not be a good use of money - \$30,000 every year. Mr. Kirk Haynes stated that, if we look around, the state, federal and surrounding counties pay twice a month. He stated that the workforce has changed since the last survey was conducted. Mr. Haynes also stated that young teachers starting out would have to wait until August before their first paycheck. Some employees are single parents and that would alleviate some of the financial burden. Mr. Haynes stated that if we take care of our employees, they will take care of our students. Mr. Haynes also suggested that the Board consider one optional day to be included in the 2020-2021 budget.
