EXHIBIT "A Legal Description

Parcel 1:

A certain tract or parcel of land lying and being in Rowan County, Kentucky, BEGINNING at a 20" white oak tree in the corner of the property herein conveyed, the property of Carl Sluss and the property of Howard and Barbour; thence with said Carl Sluss line and an existing fence, North 16° 27' East, 52.86 feet; thence South 72° 14' East, 708.64 feet to a point in the property line of Claude Brown Estate; thence with said Claude Brown Estate line and an existing fence South 17° 46' West, 425.00 feet (crossing the T.G.T. gas lines) to a wood post at the corner of the property of Howard and Barbour; thence with the existing fence line and the Howard and Barbour line for two (2) calls: North 490 [49°] 42' West, 211.44 feet to an 8" black oak, and North 42° 37' West, 589.09 feet to the point of BEGINNING, containing 4.004 acres.
