KHSAA

- KHSAA, private, non-profit organization with 280 voluntary member high schools, participating in interscholastic athletics, which is PRIVILEGE and not a guaranteed right.
- Designated by the Kentucky Board of Education to manage athletics through 702 KAR 7:065 as a part of KRS 156.070(2) and receives its enforcement authority from the Kentucky General Assembly.
- All eligibility rules and regulations must be approved through a lengthy process that starts with the member schools, and ends with the legislature. Several other groups weigh-in before a change is given final approval.

KHSAA VISION

- Adopted by the Board of Control:

KHSAA

- IS NOT: An Enforcement Agency
- IS NOT: An entity with Subpoena Power
- IS NOT: Able to swear witnesses and testimony (except for KRS Chapter 13B hearings and sworn depositions)
- IS: An association of member schools
- IS: A service entity for its member schools, providing insurance, communications and resources/tools for managing an athletic program
- IS: Funded by Dues (Pays for Insurance); Tournament Receipts from State Only and Sponsorships
- IS NOT: Funded by early round tournament receipts (as are most states)
- IS: The designated agency who, on behalf of KDE, handles athletics in the member schools
- IS: Its' collective 280 member schools NOT a specific school and not its' staff
- IS: The Agency required to develop regulations for middle school athletics
- IS NOT: An Agency that enforces the regulations for middle school athletics

RED FLAGS WITHIN THE BYLAWS

- Bylaw 2 – In Statute, but specific appeal possible
- Bylaw 4 – No one plays while repeating in 5-12, Below Grade 9 Playing Up Allowed except SO, FB
- Bylaw 5 – Conversion between credit systems, Normal Progress
- Bylaws 6, 7 and 8 – Last Date of Participation, Willingness of Sending School to Stand up and Be Heard including evidence, Forms Submission, Both Schools Having All Materials
- Bylaw 9 – Make sure your basketball players are not playing in organized events prior to October 15
- Bylaw 14 – Practice and Non-Varsity Play by Ineligible Students (online chart)
- Bylaw 22 – Opponents and Sanctioning (Home School Sanctioning)

RED FLAGS – ONLINE ROSTER REQUIREMENTS

- KHSAA online system only, no other form will substitute
- No one can play in a game unless on roster
- Reminder that per Bylaw 14, not eligible to play in games, not eligible to practice if coming into the school under Bylaws 6, 7 or 8 (transfer, foreign exchange or foreign student)
- School decides who edits rosters. Must work cooperatively with AD or Principal in getting assigned rights, or having them do the editing
- Fourth level (postseason) so that roster manipulation at end of season doesn't cause inconsistencies in yearly reporting
- Only those on postseason roster are eligible

RED FLAGS - ELIGIBILITY STATUS- BYLAW 14 & 6

- Bylaw 14 – Schools have final determination in many cases for practice ad for non-varsity play
- Students awaiting a ruling on Bylaw 6, 7, 8 may not practice.
 - Enrolls at a member school after playing varsity, they are automatically ineligible for one year from the date of their last participation. Therefore at the point of enrollment, the transferring student is ineligible and the school makes the determination as to the ability to practice.
 - If a transfer waiver request is then submitted, that student becomes ineligible to practice upon the receiving school submission to the KHSAA. That student remains ineligible to practice until the written ruling is received from the KHSAA. Once that written ruling is received, favorable or unfavorable, by the school, the school then makes the determination as to the ability to practice.
 - If an unfavorable ruling is received by the school and the student submits an appeal, the student is ineligible to practice until the Commissioner's final order is issued and received by the school in the matter. Once the final ruling is received, it is again the school's discretion as to practice by the student.

RED FLAGS - BYLAW 22 – CONTESTS, SANCTIONS, RULES, FORFEITURES


- Bylaw 22 allows member schools to play:
- Schools in Kentucky that are members of the KHSAA;
 - Out of state schools as determined by the KHSAA member;
 - Out of state schools must comply with Kentucky rules for contests in state
 - Against home school students or groups of students (legislative change). Reminder: Home Schooled students cannot play FOR a KHSAA member, only against.
- No rules deviation from NFHS for contests played in state
- NFHS Sanctioning Required for host school if:
 - Non-bordering states if five or more states involved
 - Non-bordering states if more than eight (8) teams involved
 - More than two (2) schools with a titled sponsor with tangible benefits provided

RED FLAGS - BYLAW 23 – USE OF SCHOOL FACILITY IN OFF-SEASON


- Bylaw 23 requires no organized interscholastic play on school facility (or competition against any outside opponent) during school year outside of limitation of seasons
- Facility may only be used during these periods for sports specific play if a market value lease with the third party organization (with no affiliation with the school or any member of the athletics staff) and if no students or coaches from that school participate in any way
- No play involving outside players if more than 1/2 of squad size involved
- No "open gym" kids from non-feeder without permission

RED FLAGS - BYLAW 24, DEAD PERIOD


- June 25 through July 9, including both of those days
- Dead is dead, nothing sports specific involving coaches and players
- Includes all sports and sports activities, high school coaches cannot be involved with high school kids
- Minimal exceptions include postseason celebrations for teams in KHSAA spring state events
- Coaches cannot be involved in sports specific activity at their schools regardless of age and arrangement
- Changes in Open Gym for Summer, permission of teams

RED FLAGS - BYLAW 25 - COACH AND AD REQUIREMENTS

- Coaches
 - Coaching Ed – Level 1 coach not continuously on faculty since 95-96
 - All Level 2 coaches
 - Grandfathering goes away when they retire from teaching or leave district
- AD Requirements
 - 18 hours first three years
 - 12 hours after three years

DATA SYSTEM FUNDAMENTALS


- SECURE LOGIN REQUIREMENT
 - If user is logged in as someone else (i.e. using an AD login name, another coach, etc., YOU will not receive credit.
 - If this is the case, contact your AD and ensure that you are properly entered as a coach in the school system database.
- COMPLETION REQUIREMENT
 - If user does not have time to complete this clinic now, logout now. You cannot stop and start, do a little at a time. It is to be completed at one time.
 - Persons starting and then not completing will NOT be given credit and will have to start the clinic again at a later time.

COMPETITION REMINDERS – UNIFORM DEVIATION POLICY


- No deviations from NFHS rules
- Applies to all types of deviations (military night, green night, pink night, etc.)
- NFHS Rule Book Policies must be adhered to in all sports. i.e. if White jersey required, no waiver for pink or green or camo, etc.
- Note many other items are not regulated (warm-ups, socks in some sports, shorts in some sports, wrist bands in some sports, etc.)

REQUIREMENT TO USE OFFICIAL BALL

- KHSAA under contract through 2019 with Spalding to be official ball for Baseball, Basketball and Football
- KHSAA under contract through 2019 with Dudley to be official ball for Softball
- KHSAA under contract through 2019 with Baden for Volleyball
- KHSAA under contract through 2019 with Select for Soccer
- Required for all play to be proper brand with NFHS logo.
- No requirement for KHSAA logo on any required ball
- No penalty for regular season lack of use
- Administrative penalty for failure to use in postseason (fine, possible suspension)

- Hearing Attendance

- 25,000 deductible, \$6M Maximum

- Board Option as to Who Pays 0-\$25K

OBLIGATION OF ALL TO HELP RECRUIT, TRAIN AND MENTOR OFFICIALS


- Numbers in some sports saw sharp decline in 17-18 (soccer, baseball, wrestling)
- Recent survey showed same results statewide and nationally (NASO)
 - Obligation of schools to ensure safe environment. Significant percentage felt unsafe
 - Unchecked fan and coach abuse and treatment (verbal and physical)
 - More than 10% of officials claim they are publicly critical of other officials
- Social media limitations on both coaches and officials
- Need to recruit, but also need EVERYONE working to allow new officials to learn on the fly, just like players and coaches do!
- Coaches play a pivotal role in this effort, and will be the main ones in addition to kids harmed if we see shortage
- Veteran officials must mentor young officials and ensure continued interest

OFFICIALS DIVISION

- Officials Division, Recruiting and Retention
 - Recruiting of young officials down
 - Trouble spots include Soccer and Wrestling
- Assigning Secretaries and 9-12 Authority
- Policy Boards and 9-12 Authority
- Varsity Pay Scale set by Board, reviewed every four years
- Non-Varsity Pay Scale revisions for postseason to be considered year after Board reviews varsity (ONLY)
- ArbiterPay
- Junior High/Middle School officials must be licensed by KHSAA

OFFICIALS DIVISION

- Changes by Board of Control upon recommendation of Commissioner
- Scratches, Minimum 2 maximum 3 and must be local to that region
- Evaluation module within Arbiter to be only evaluation system
- Assigners pay will be collected by one entity per region, remitted to KHSAA to distribute to ensure issuance of 1099 and other documents
- Issues being addressed with assigners working "out of region"

STATISTICS AND SPORTS INFORMATION ITEMS

- **Statistics Submission**
 - Ultimate objective is benefit for the students
 - Required in Football, Basketball, Field Hockey, Soccer, Baseball and Softball
 - Ongoing expansion of data collected
 - Enter each game, game by game
 - Missed submissions (later than 72 hours) will be subject to \$100 per late submission
 - Official Entry and Compilation Remaining Internal to KHSAA
- **Picture Submission**
 - Required in baseball, basketball, field hockey, football, soccer, softball and volleyball including outline
 - Only exception is we receive letter signed by all school authorities that you don't have any type of team picture taken for any purpose
 - First notice (deadline) will be reprimand
 - Second will be fine to the school

REQUIREMENTS FOR ELIGIBILITY FOR PARTICIPATION

- Eligibility rules are forever changing
- Coaches shall always consult the Athletic Director or Principal of the school to verify eligibility
- With the exception of students involved in a Due Process case regarding Bylaw 6 (Domestic transfer), Bylaw 7 (Foreign Exchange), or Bylaw 8 (Foreign Student), schools may be guided by the chart at <https://khsaa.org/051017-reminders-about-students-practicingplaying-while-ineligible/>.
- Any student awaiting an initial ruling on a transfer (Bylaws 6, 7 or 8) is ineligible while the ruling is pending and until a ruling is received in writing. **ONLY ACCEPT A RULING FROM SCHOOL ADMINISTRATION**
- If a student who is ineligible decides to appeal, that student is not eligible to practice until the Due Process matter is completed and a written ruling received.
- Keep in mind that the hearing officer's letter is not a ruling, only a recommendation. **ONLY ACCEPT A WRITTEN RULING FROM SCHOOL ADMINISTRATION BASED ON OFFICIAL CORRESPONDENCE**

FAN BEHAVIOR

- Officials should not directly eject fans, however, officials have every right to halt a contest until school administrators remove an unruly or unsportsmanlike fan.
- In that case, officials should penalize as necessary within the rules, find the previously identified game administration and direct the removal, and if such does not occur, the game can be terminated within the rules and the KHSAA notified through the use of an online incident report.

FAN BEHAVIOR

- Everyone in this great country has freedom of speech, but not consequences from what you say, particular in a “privilege” environment. Simply paying for a ticket doesn’t give you unfettered and unrestricted ability

ASSISTANT / NON VARSITY COACH BEHAVIOR

- Targeted emphasis on conduct in non-varsity games by coaches, and assistant coaches in varsity contests
- Officials instructed to rigidly enforce conduct restrictions on these individuals
- Officials should have the wisdom to have a certain amount of leniency for the head coach in varsity contests, but deal with them professionally
- This sideline conduct is number one reason for loss of officials.
- Not coach’s job to “see what they can take”. Officials are learning, just like coaches and players

DRONES (REMINDER)



- Not legal at any scrimmage, regular or postseason contest
- Highly recommend not use in any practice session due to FAA restrictions
- If even considering for practice, get in writing from insurance carrier that coverage is bound if individuals are present
- FAA rules require registration but continue to disallow at events where not participants are involved (fans, etc.)
- Officials encountering drones during a game are to stop the contest, and seek game administration to ensure removal before resuming play, report on incident form
