Since that time, the Board of Commissioners has determined that it is in the best interest of all parties involved to repeal Ordinance 16-2019.

**4.G.** Consider Ordinance 23-2019 entitled AN ORDINANCE REPEALING ORDINANCE 17-2019 IN ITS ENTIRETY, WHICH WAS APPROVED BY THE OWENSBORO BOARD OF COMMISSIONERS ON JUNE 4, 2019, DECLARING THE CITY OF OWENSBORO'S INTENT TO ANNEX INTO THE CITY CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2909 HIGHWAY 54, CONTAINING 14.877 ACRES, MORE OR LESS, was introduced and publicly read on first reading.

On June 4, 2019 the Owensboro Board of Commissioners approved Ordinance 17-2019 declaring the City's intent to annex into the City certain unincorporated territory

in the County of Daviess adjoining the present boundary line of the City, being property located at 2909 Highway 54, containing 14.877 acres, more or less. Since that time, the Board of Commissioners has determined that it is in the best interest of all parties involved to repeal Ordinance 17-2019.

Commissioner Conder asked for clarification if the agreements with both Daviess County Public Schools and Daviess County Fiscal Court would go away with these ordinances; to which City Manager Pagan said they would. Mayor Pro Tem Larry Maglinger stated that he will be out of town at the meeting to vote on the ordinances; however, he would have voted in favor of them. Mayor Watson read a statement outlining his thoughts on the annexations (attached).

## 5. PRESENTATIONS

- **5.A.** Pamela Canary, Transit Manager gave an update on Transit (attached). Mayor Watson thanked her for establishing communication lines at the state and national level.
- **5.B.** Lelan Hancock, Assistant City Manager, mentioned a few of the items on the OBKY long-term project that are on-going: downtown affordable housing, English Park RV Park, Neighborhood Alliance Board 2.0 and customer service training has taken place; short-term goals of OBKY community policing, the District, community financing and downtown arts project. Two murals are coming out soon in the downtown area. Mayor's Mile banners are hung and Miley (the pig) should be back on display soon.
- **5.C.** The District update was given by Tim Ross, Public Events Director. To date, police have reported no issues and most businesses are seeing an increase in sales. In fact, the businesses have suggested expanding the days/hours of the District beyond just Fridays.
- **5.D.** Fire Chief Steve Mitchell gave an update on the recent ambulance transition (attached). To summarize, the ambulance service seamlessly changed over to AMR on June 30 at 7:00 pm. Many hours of meetings and details went into the contract negotiations and implementation. Sixty-three (63) of sixty-five (65) full and part-time employees have been hired. Mayor Watson passed along the compliments from those that worked with Chief Mitchell on his performance of this process of transition.
- 6. City Project List the fence contractor at the dog park should be onsite Wednesday (tomorrow) to begin work. Triplett Twist private investment dramatically increased due to the Wabuck Development project, Senior Grace living facility moving forward with an \$8.5-\$9 million investment. Lucas Knight, senior at WKU, is a summer intern working with the Community Development Department.

Mayor Watson announced the next meeting will be a Special Called meeting on Thursday, July 11 at 4:30 pm.
