These fees are deposited into each individual club account within the ACSHS Activity Fund for students who choose to join any of the above noted clubs. The funds are used to offset the cost of field trips, purchase club t-shirts, purchase supplies for club activities and community service projects as well as affiliation dues with state and national clubs.
