Motion to accept: Newsom, second by Elumalai Motion was approved by consensus.

New Business

Mr. Tatum shared the Staff Allocations for 2019-20 document. According to the numbers MCSH is down two certified positions. He explained the district allocation guidelines.

Mrs. Russell explained 8th grade numbers had been accounted for based on test scores, previous requests and class enrollment. Goss and Russell implemented the google forms with English classes. The Trailblazer Academy commitment is a minimum of 3 english periods so that leaves 2 sections short in english. Mercer Central requirement is 5 periods (1 full teacher). Elumalai expressed concern about AP Stats not making a section and Physics must be built up since it's the first time we're offering it. McClain also expressed concern about Physics saying engineering students need it and inquired about the online option. Social Studies sections work out even. Health & PE will be completed in a semester next year so this department is over 6.5 periods. Ag is 5 periods over. Business has more sections than staff so personal finance students can be moved to Money Skills. FCS has 5 periods above requests. Engineering needs 3 so 2 could be used at MC for math/science. Music & Humanities are 2 sections short. Band could be traded for 1 Spanish period at KMS. Foreign Language has 3 extra sections. Arts ections work out even.

Mr. Tatum reiterated that our students drive the courses offered based on the requests and based on the district allocation. Rowland asked for Tatum's suggestion for solving the problem. Tatum recommends hiring 1 english position, reduce 1 PE position, reduce 1 Ag position, and reduce 1 FCS position.

SBDM discussion:
