Lincoln Elementary currently has 40-45 students identified with disabilities that are serviced through a multitude of placement settings from general education with supports, co-teaching classrooms, and resource classrooms. These students are serviced by 5.5 teachers and 4 para-educators.

The current Chromebook resources available for each teacher is 0-8 chromebooks per teacher (~28 working chromebooks). The number of students in a classroom is anywhere from 5-12 students at a time in a classroom. This will at minimum require access to 28-40 chromebooks at a time for some portions of the day. With those classes being closer to 12 than 5 for the majority of the core instructional periods. Students have been asked school wide to have 7 books read and tested per quarter via an online model, they are required to have a specific amount of minutes of usage in an online math program, and they are to construct written responses to prompts. Many of our students do not have access to technology and the internet outside of the school setting and require supports to complete the online requirements that we can provide in the special education setting. Students have access to a variety of online resources such as Read Write Google, Google Docs, Accelerated Reader, EPIC, Story Works, Read Works, System 44/Read 180, Edit book, Screencastify, and Google Classroom; to list a few examples. We simply do not have enough technology resources available to cover the needs at the same time. Our students also struggle to get logged in independently and having 1:1 devices in each classroom eliminates the need for some of that as they are logged in and do not have to switch users especially since they already have a reduction in time due to transitions from the general education setting or groups when they travel to resource rooms as required per their Individual Education Plan. Many of these students struggle with physical coordination as well and travel with materials can be a struggle so traveling with chromebooks is a risk for dropping or losing the device so these devices need to be stationary in the classrooms or transported via a staff member when absolutely necessary.

Simpson County needs individuals qualified as life and career ready when they graduate from high school. In order for that to happen for our students with disabilities we need to have literacy and mathematical skills that are the building blocks for all future learning. The access to 1:1 technology will help Lincoln Elementary's special education teachers to work toward reducing the educational performance gap in our students and increase the number of students who graduate life ready.
