SUMMARY OF ISSUE BEFORE THE BOARD:

To take action on proposed annual amendments to the Kentucky Tech Policies and Procedures.

COMMISSIONER'S RECOMMENDATION:

The Commissioner recommends approval of the amendments to the Kentucky Tech Policies and Procedures to align and update the policies and procedures with pertinent new legislation, as well as best practices recommended by the KSBA.

APPLICABLE STATUTE OR REGULATION:

KRS 156.802

BACKGROUND:

Existing Policy:

The Kentucky Department of Education (KDE) has the responsibility for all administrative functions of the state in relation to the management, control and operation of the secondary Area Technology Centers (ATCs). The ATCs shall be operated in compliance with program standards established by the Kentucky Board of Education (KBE). The Kentucky Tech Policies and Procedures guide the work of the administrators, teachers and staff within the 53 ATCs and ensure consistent practice that is compliant with relevant state and federal statutes, regulations and policies.

Summary of Issue:

The Kentucky Department of Education (KDE) contracts with the Kentucky School Boards Association (KSBA) for annual maintenance, revision and upkeep of the Kentucky Tech Policies and Procedures. The annual changes are intended to align and update the policies and procedures with pertinent new legislation, as well as best practices recommended by the KSBA. The specific policy documents that are impacted by these amendments are attached for review.

Budget Impact:

The proposed amendments to the Kentucky Tech Policies and Procedures have no fiscal impact on state funds.


GROUPS CONSULTED AND BRIEF SUMMARY OF RESPONSES:
