



For the past 10 years, A WIRED FAMILY has offered our social media and technology program to schools, mental health organizations and businesses. Our single objective has been to keep the children in our community safe online.

Following my retirement from Cincinnati Bell in September of 2017, Mary Beth and I wanted to be certain that the program would continue. For the first time in 8 years we had to charge a fee to help recover our cost. The program grew while also allowing us to produce free resources such as over 50 videos and 60 articles that help parents manage their children's online activity. During the 2018-2019 school year, we have served over 100 different schools and organizations with over 200 presentations. Interestingly, during our 10 years, we have presented to nearly 500,000 people.

However, throughout the past two years, cost recovery has been a challenge. As such, to continue our program, we must increase our presentation fees to assure the program's future existence. Increasing fees is the last decision we want to make. However, we can't run a deficit and continue the quality of the program and the free website, videos and articles. That said, we feel our new fees are in line with those of other speakers on any number of subjects.

BELOW IS AN OVERVIEW OF OUR FEE SCHEDULE FOR 2019-2020

Up to two consecutive, student presentations = \$1000

-Add a third student presentation within one hour of the first 2 = additional \$500

PRESENTATION LENGTH

-1st-2nd grade student presentations 30 minutes long

-3rd-5th grade student presentations are 40-45 minutes

-6th-12th grade presentations are 60 minutes long.

-Staff training: \$1500 for a 90 minute presentation before or after school

-Parent training: \$1000 for a 90 minute evening presentation

Custom packages available upon request.

There is a travel fee of \$100 for presentations located between 50 and 75 miles from our office in North Bend, Ohio.

For example: If your location is located within 50 miles of our office, there is no additional cost.

If you are located 51 – 75 miles there is a \$100 added fee.

Beyond 75 miles, the fee is \$100 plus \$6.00 per mile for every mile over 75 miles.

Please note, that mileage /time is calculated from our office in North Bend, Ohio to your location and then the return trip home. Travel charges are for both time and mileage.

For example: If your location is 100 miles from our office you'll be charged accordingly:

- \$1000 for the presentation
- Added fee of \$100 due to mileage and time to get to your location and return home
- Plus \$6.00 per mile over 75 miles.

NOTE: Anything over 150 miles will be charged on a case-by-case basis.

Mary Beth and I thank you for all of your past support of our program. We hope that you have found the service of value for your schools and the children in your care.
