### **Additional Terms and Conditions**

- 9. The artist(s) stated herein is an independent contractor and assumes all responsibility for withholding taxes, Social Security, state taxes, public liability, and workman's compensation insurance and also assumes responsibility for insurance coverage to, from and on engagement and for accident or injury to himself and/or his equipment.
- 10. In the event of any inconsistency between the provisions of this contract and the provisions of any riders, addenda, exhibits or any other attachments hereto, the parties agree that the provisions most favorable to PRODUCER and ARTIST shall control.
- 11. PURCHASER hereby indemnifies and holds PRODUCER and ARTIST, as well as their respective agents, representatives, principals, employees, officers and directors, harmless from and against any loss, damage or expenses, including reasonable attorneys' fees, incurred or suffered by or threatened against PRODUCER and ARTIST or any of the foregoing in connection with or as a result of any claim for personal injury or property damage or otherwise brought by on or behalf of any third party person, firm or corporation as a result of or in connection with the engagement, which claim does not result from the active negligence of the ARTIST and/or PRODUCER.
- 12. PRODUCER'S obligations thereunder are subject to detention or prevention by sickness, inability to perform, accident, means of transportation, Acts of God, riots, strikes, labor difficulties, epidemics, any act of any public authority or any other cause, similar or dissimilar, beyond PRODUCER'S control.
- 13. In the event of illness, strike, law, Act of God, government regulation or other force majeure occurrence, PRODUCER is unable or is prevented from performing the engagement or any part thereof, PURCHASER shall be obligated and liable to PRODUCER for such proportionate amount of the payment provided for herein as may be due thereunder for any performance(s) which PRODUCER may have rendered up to the time of the inability to perform by reason of such illness or force majeure occurrence. This agreement is between the undersigned PURCHASER and the PRODUCER, or the artist(s) stated herein and is not subject to cancellation except by mutual agreements, Acts of God, proven detention by sickness, accident to means of transportation, riots, strikes, epidemics, or other legal condition beyond the control of the PRODUCER or PURCHASER.
- 14. Notwithstanding anything contained herein, inclement weather shall not be deemed to be a force majeure occurrence and the PURCHASER shall remain liable for payment of the full contract price even if the performance(s) called for herein are prevented by such weather conditions. PRODUCER shall have the sole right to determine in good faith whether any such weather conditions shall render the performance(s) impossible, hazardous or unsafe.
- 15. MATRIX ENTERTAINMENT is licensed, bonded, and operates under the laws of the State of Michigan and is regulated by the Michigan Talent invenstment Agency, Dept of Talent & Economic Development. P.O. Box 30018, Lansing, Michigan (Phone: AC(517) 373-8490).
- 16. If payment is not received within thirty (30) days from date of engagement, PRODUCER reserves the right to assess interest on the unpaid amount at the lower of the maximum legal rate of interest or 1 1/2% per month. If the PURCHASER breaches this agreement and this contract is placed in the hands of any attorney for legal proceedings, PURCHASER shall pay in addition to PRODUCER'S damages, interest on the unpaid amount at the lower of the maximum legal rate of interest or 1 1/2% per month, together with a reasonable attorneys fee.
- 17. This constitutes the sole, complete and binding agreement between the parties hereto. This agreement may not be changed, modified or altered except by an instrument in writing signed by the parties. This agreement shall be construed in accordance with the laws of the State of Michigan applicable to agreements entered into and wholly to be performed therein. Unless stipulated to the contrary in writing, all disputes arising out of this agreement, wherever derived, shall be resolved in Kent County in the State of Michigan in accordance with the laws of that State. In the event of any such dispute, either party may effect service of process on the other party by certified mail, return receipt requested, and said service shall be equivalent to personal service and shall confer personal jurisdiction on the courts in the State of Michigan and shall be deemed effective upon the earlier of the recipient's mall receipt date or ten (10) days after the mailing of such process, provided that a duplicate of such process shall have been mailed to the other party by ordinary mail at the same time as the certified mailing. PURCHASER shall not have the right to assign this agreement, or any provision thereof, but PRODUCER shall have the right, from time to time, and at any time, to assign its rights and/or delegate its obligations thereunder, in whole or in part to any person, firm or corporation.
- 18. Nothing herein contained shall ever be construed as to constitute the parties hereto as a partnership, or joint venture, nor to make PRODUCER liable in whole or in part for any obligation that may be incurred by PURCHASER in PURCHASER'S carrying out any of the provisions hereof, or otherwise. THE PERSONS EXECUTING THIS AGREEMENT ON PURCHASER'S BEHALF WARRANTS HIS AUTHORITY TO DO SO, AND SUCH PERSON HEREBY PERSONALLY ASSUMES LIABILITY FOR THE PAYMENT OF THE CONTRACT PRICE IN FULL.
