**Logan County Schools Vision Services Contract  
2019-20 School Year**

This contract is entered into this \_\_\_\_\_ day of \_\_\_\_\_ 2019, between the Logan County Board of Education and the Todd County Board of Education for the provision of vision services for up to, but not to exceed, four (4) full days per month.

The Logan County Board of Education will maintain copies of all certifications for the Teacher of the Visually Impaired as required by the Professional Standards Board.

The Todd County Board of Education will provide any equipment/supplies and necessary space/privacy as needed for vision services on an individual basis.

Whereas that said Teacher of the Visually Impaired has been duly appointed by the Superintendent of Logan County Schools for the 2019-20 school year, the parties to this contract hereby agree to the following conditions:

- 1) The services to be performed by the Teacher of the Visually Impaired shall be to provide services to students with visual impairments. These services will consist of:
  - a) Traveling to schools where the student with VI are enrolled;
  - b) Conducting and/or aiding with evaluations of suspected and identified student with VI;
  - c) Providing consultation to teaching staff, suggesting appropriate activities for the Student with VI, providing direct services to student with VI as appropriate;
  - d) Assisting with the development of appropriate goals in the Individual Education Plan (IEP) process and attending ARC meetings as appropriate;
  - e) Assisting with the identification and selection of appropriate materials and/or equipment and when appropriate, meet with parents of student with VI to discuss activities.
- 2) The duties to be performed are to commence on July 1, 2019, and will end no later than June 30, 2020.
- 3) In consideration of the services provided by this contract, the Logan County Board of Education shall be paid the equivalency of \$100.00 per half-day visit and services, or \$200 per full-day.
- 4) The Teacher of the Visually Impaired shall keep records, reports, and furnish the same to the Todd County Superintendent and/or Director of Special Education at regular periods designated by him/her, state law, the lawful rules and regulations of the State Board of Elementary and Secondary Education, and the lawful rules and regulations of the school district.
- 5) This agreement may be terminated at any time by either party, with or without cause, by giving thirty (30) days written notice by certified registered mail of intention to the other party.
