These students have difficulty sitting at traditional desks or tables. The alternative seating with portable desks I have chosen will enable the students to have a choice of where they sit and to feel comfortable while being engaged in their learning. I think this type of atmosphere will allow the students to be motivated to be more successful in completing their learning tasks. The middle school is a Renaissance school which encourages making a change to inspire greatness and a feeling of success in our students. When students are relaxed and comfortable they seem to perform better on their educational tasks.

I am also applying for this grant to be able to purchase a laptop. I will use this laptop to load educational programs for the students to alternate the use of as a learning tool. I will also use this laptop to complete IEPs, progress monitoring, and other data necessary to analyze and diversify their learning needs.
