GATEWAY ACADEMY/BREATHITT CENTER RENOVATIONS/ADDITIONS

Andrew Owens with Sherman, Carter, Barnhart Architects was present to provide an update on Gateway Academy/Breathitt Center Renovations and Additions. Mr.

Owens updated the board on the work completed and stated there are just a few more punch list items left. He stated the building is being occupied and staff are moving in. Mr.

Hawkins stated there will be a ribbon cutting and open house

for the public on August 5 at 5:00 p.m.

MILLBROOKE BRIDGE UPDATE

Mr. Brad Hawkins, Chief Operations Officer and Mr. Ryan Amerson, Principal, Millbrooke Elementary School, gave the board an update on the Millbrooke Drive Bridge Repair and how they intend to handle traffic issues while the bridge is being completed.

Mr. Amerson gave the board an overview of the details on the construction project and ways to minimize the traffic on the road. They will work to communicate these changes to their student guardians.

SOCIAL WORK AND TRANSITION UPDATE

Kim Stevenson, Director of Alternative Programs and Brandy Westerfield, Social Worker, presented the board with a PowerPoint presentation update of the social work and transition update (a copy of which is attached to the board minutes.)

Ms. Stevenson stated that Christian County Public Schools is privileged to have three schools based therapist in their schools. She introduced Ms. Westerfield for the Social Work Update.

Ms. Westerfield discussed the number of student sessions during the 2018-2019 school year as well as numerous parent/guardian meetings and/or consultations with teachers and staff. Ms. Westerfield touched base on the work they completed, community collaboration and looking ahead to the 2019-2020 school year.

CHRISTIAN COUNTY PUBLIC SCHOOLS END OF YEAR DISCIPLINE DATA AND ALTERNATIVE PROGRAMS UPDATE

Melanie Barrett, Director of Pupil Personnel and Kim Stevenson, Director of Alternative Programs, was present to give the board an update on the 2018-2019 discipline data (a copy of which is attached and the terms of which are incorporated by reference.)

Ms. Barrett began the presentation by reviewing all discipline data for the 2018-2019 school year. Data was compared from 2014 to present. Ms. Barrett also reviewed trends, discipline events, referrals, disparity, in school suspension, infractions, arrests, etc.

Ms. Stevenson updated the board on CCPS's Transition Program. She discussed the number of students serviced in the 2018-2019 school year. Ms. Stevenson gave the board an overview of the changes that will be occurring in the Alternative Program this year. Ms. Stevenson also gave the board an update on the Positive Behavior and Intervention Supports during the 2018-2019 school year. Ms. Stevenson discussed goals for the 2019-2020 school year.

INSTRUCTIONAL UPDATE: CENSUS 2020

Susie Hartline, Director of Strategic Planning, Federal Programs, and Grant Development, was present to give the board an Instructional Update on Census 2020 (a copy of which is attached to the minutes.)

Ms. Hartline discussed the importance of participation in the Census and how Census data effects educational funding. She addressed there is concern as young children are the most undercounted age group in the census, but a plan is being put in place to ensure that all children accounted for in Christian County.

COMMITTEE REPORTS

Mr. Clark

Mr. Clark spoke to two State Representatives who will be going into session beginning tomorrow regarding quasi-governmental agency pension discussions. Mr. Clark stated the TRS Retirement System will not be in discussion this session, however when they return to session in 2020 they will discuss fully funding the retirement system.

Mr. Clark also stated the representatives are working to alleviate the red tape in recruiting Tennessee teachers to Kentucky.

Mr. Bell

Mr. Bell stated they are continuing their Community Wide Book Study and their next meeting on July 24th will go over the final chapters of 15 and 16. Mr. Bell stated they are also working on a new Community Vision Plan and encourages all citizens to go by the Chamber of Commerce to fill out the survey to give them input for the new vision plan.

Ms. Hayes

Ms. Hayes stated she received an AARP magazine and in it was our 5th grade student from Millbrooke Elementary School, Sabastian Dazey. He was recognized at our June Board Meeting for winning the 2019 Grandparent of the Year Essay Contest.

Mr. Moore

Mr. Moore stated the PBIS committee met this morning to discuss the upcoming school year. It will be mandatory all schools be Tier II. Mr. Moore stated it all begins with consistency and training for teachers and staff.
