<u>Consent Agenda Item (Action Item)</u>: Consider utilizing CERT assessments for all students in Grades 6-11 at all Floyd County Schools for the 2019-20 school year.

Applicable Statute or Regulation: Board Policy 01.11 General Powers and Duties of the Board

<u>Fiscal/Budgetary Impact:</u> There will be no budgetary impact as the GearUp progam will purchase the assessment program for all Floyd County students.

History/Background: CERT stands for College Equipped Readiness Tool and provides administrators, teachers, parents and students with information they need to maximize career and college opportunities for students. Reports include individual and group composite performance by subject area (Reading, Math, Science and English) as well as three levels of Career and College Readiness Standards. The students performance on subject-specific content is organized using language that is familiar to students and teachers. The exam is online and provides each student performance feedback and video answer explanations for each and every test question as well as an online Study Hall that recommends subject matter strategy and video lessons based on each individual students performance. The data provided will assist schools and teachers greatly in providing ontime MTSS services. The CERT Assessment will be given 3 X's yearly with results analyzed to inform instruction and programming. (See attached assessment plan)

Recommended Action: Approve the use of CERT assessment for all students in grades 6-11 at all Floyd County Schools for the 2019-20 school year.
