The General Fund tax levied in fiscal year 2019 was 68.2 cents on real property and 68.2 cents for personal property and produced revenue of \$17,128,051.78. The proposed General Fund tax rates of 69.3 cents for real property and 69.3 cents for tangible property are expected to produce \$18,473,898.27 for 2020. Of this amount, \$2,144,368.31 is from new and personal property. The compensating tax rates for 2020 is 66.7 cents for real property and 66.7 cents for personal property and are expected to produce \$17,780,793.86. The general areas to which revenue of \$1,345,846.49 above the 2019 revenue is to be allocated are as follows: Cost of collections \$26,917, instruction \$1,118,929.49 and facilities and maintenance \$200,000.
