8. FY 2020 Tax Levy

Discussion:

Lowering the rate will reduce the TVA In-lieu of tax revenue. Current Tax Levy is 45.8 cents. Compensating tax rate means that we are projected to have the same revenue as the prior year. A hearing is not required. The Compensating rates would be 44.7 and 45.8 which means that the appraisal values have gone up. .01 cents can be added for exonerations (uncollected taxes for the prior year). No hearing required. Item E is a "44 cent equivalent rate." The tax levee would be 47.6 cents and would provide an increase of revenue about \$75k more than the 4% increase. A hearing is not required. 47.6 cent levee is lower than Crittenden (48.7), higher than Lyon (44.9)
