## Affinity Debit Card Agreement

This agreement is for the mutual benefit of Allen County Schools (Participant) and MidWest America Federal Credit Union (MidWest).

1. Participant agrees to allow use of their logo on MidWest debit cards and any associated marketing material.
2. MidWest will provide sample for approval prior to public offering of card.
3. MidWest agrees to allow Participant use of MidWest's name and logo for marketing of said cards.
4. MidWest will pay Participant an upfront fee of:
  - a. \$5,000 – year one
  - b. \$3,000 – year two
  - c. \$2,000 – year three
  - d. \$1,000 – years four and five
  - e. Payment will be made within 30 days of card holder approval in item 2, subsequent payments annually thereafter.
  - f. Upfront fees are only for initial 5 year term.
5. MidWest will pay Participant 4 cents per cardholder "Swipes", either signature or PIN.
6. MidWest will produce, if requested, the number of swipes that affect the payments under section 5.
7. First payments of section 5 will take place in February 2020; and semi-annually thereafter.
8. Both parties understand that this is simply a debit card attached to regular checking accounts offered by MidWest and Participant has no liability for any losses on the actual account.
9. MidWest agrees to indemnify and defend participant in the event any claims are made against Participant.
10. Term of this agreement is 5 years from signature date. It will automatically renew for additional 5 year periods.
11. Either party may terminate this agreement by providing written notice within 90 days of the renewal date.
12. Participant agrees MidWest will be the exclusive provider of Affinity debit cards for the term/renewals of the agreement. Participant stipulates there are no existing contracts with any other financial institutions offering debit cards with the ACS logo.
