The meeting was called to order at 3:06 pm. Motion: Janice Cornett Second: Megan Hall

Review/Approval of minutes Members received copies of the May minutes. After briefly reviewing a motion to approve was made by Janice Cornett Second Jessica Hall

<u>Financial Report:</u> Council reviewed an updated financial report. There were no questions. Motion to approve: Jessica Hall Second: Rebecca Hamilton

Review & Approve Budget FY 19/20: Council members were given a copy of the new budget, Cissy discussed the need to increase the project clerk's hours. When hired in FY 18/19, her contract was 20 hours a week at 180 days at an hourly rate of \$14.00 equaling \$10,080.00 annually (excluding fringe benefits). Cissy explained the need to have the clerk in the center more often, due to the coordinator serving on various councils, being away for meetings along with numerous other duties regarding the role of the coordinator. Furthermore, the students, families and community members would benefit greatly due to the availability of someone being here (in the center) to meet their needs. The council agreed. The proposed increase: FY 19/20, 30 hours per week at 180 days per year. At \$14.00 an hour the annual income would be \$15,120.00 (excluding fringe benefits). The council reviewed the annual income with the fringe benefits and agreed funding should be used for this increase. Motion to accept: Jessica Hall Second: Rebecca Hall There were no questions pertaining to the budget/funds. Motion to accept: Deb Short Second: Megan Hall

FRYSC Advisory Council: Members discussed few potential people they would ask to serve, the council needs 2 parents and 1 community member to be in compliance. A motion was made by Megan Hall to ask Veronica Johnson to serve as a parent rep. and Beanie Moore to serve as a community rep. The motion was seconded by

Jessica Hall. Council members will continue to look for people who would be willing to serve on the council.
