Following are status reports on the following projects:

### BALLYSHANNON MIDDLE SCHOOL (BG #15-279 / REH #129-1214-A)

Century Construction continues to work on remaining warranty items and any new issues will continue to be addressed during the one year period of corrections. Closeout documentation is in process and the BG-4 and BG-5 Contract and Project Closeout forms will be presented for approval at a future meeting.

## BOONE COUNTY BUS MAINTENANCE - ADDITION (BG #19-103 / REH #129-918-D)

This project has been awarded to Millay & Company and regular progress meetings are being held to monitor progress. They are currently working on final finishes which are scheduled to be completed by the end of this month.

# BOONE COUNTY CENTRAL OFFICE ANNEX (LEARNING SUPPORT SERVICES) - RENOVATIONS (BG #19-104 / REH #129-918-D)
