## Surplus Technology Equipment Bid # 9-19-5-9

Bid Invitations were sent to 2<sup>nd</sup> Gear, Imaan International, Relay Network, Secure Recycling, Service Express, as well as posting on the Web Page and publishing notice in the paper for this bid. We received bids from all vendors listed above as well as TDF Computing and Holy Name School. Relay Networks had the highest bid for some items as well as Secure Recycling for others. We are recommending you award the contract to Relay Networks and Secure Recycling.

#### **Bid Renewals:**

#### **Art Supplies Bid # 9-18-6-10**

Seven vendors have a contract for Art supplies. ACE Educational Supplies, Inc., Cascade School supplies, Dick Blick, Lakeshore Learning, Oriental Trading, S & S Worldwide & Quill. Six of the seven vendors have agreed to renew under the same terms and conditions as the original contract. ACE Educational Supplies has not responded. They will no longer be an approved vendor. We are recommending renewal of the six vendors for an additional year.

#### Gasoline & Diesel Fuel Bid # 18-16-5-11

Home Oil & Gas Company currently has the contract for gasoline & diesel fuel until November 30, 2019. Fuel prices currently are comparable to prices last year, at this time. The company has agreed to renew the contract with us for the same terms and conditions as last year. The rack price fluctuates but the margin of profit per gallon will remain the same as it was with the contract in 2016. We recommend renewing with Home Oil & Gas Company for an additional year.

### Science Supplies Bid # 16-16-5-11

Eleven vendors have a contract with us for Science Supplies. All but one vendor returned agreements to renew their contract at the original terms and conditions. These vendors allow the schools to choose the best product for their specific needs. We recommend renewing the bid with each of the following companies: Acorn Naturalists, Carolina Biological Supply Co., Fisher Scientific Company LLC, Flinn Scientific, Inc., Frey Scientific/School Specialty, Mark My Words, LLC, Nasco, Pitsco Education, School Outfitters, LLD, and Ward's Science/VWR International LLC. The following did not respond to our request to renew. ACE Educational Supplies, Inc. did not respond to our request to renew. They will no longer be an approved vendor. We recommend renewing with the ten vendors for another year.

## **Teaching Supplies Bid # 15-16-5-11**

Eighteen vendors have a contract with us for Teaching Supplies. We received seventeen letters back from vendors agreeing to renew the contract with the original terms and conditions of the bid. We recommend renewing with, Business Equipment, EAI Education, ETA/hand 2 mind, Fisher Scientific Company, Innovative Learning Concepts now TouchMath Acquitions, LLC, Inc., Jr. Library Guild, Kaplan Early Learning, Lakeshore Learning Materials, Mark My Words, LLC, National Educational System, Quill Corporation, Really Good Stuff, S & S Worldwide, School Specialty, Schoolhouse Outfitters, Smith and Butterfield, and Steps to Literacy. ACE Educational Supplies did not respond to our request to renew. They will no longer be an approved vendor. We recommend renewing with the seventeen vendors for another year.

# T-Shirts, Sweatpants/Shirts, & Polo's Bid # 19-16-5-11

Fifteen vendors have a contract for T-shirts, sweatshirts/pants and polos. All but one has agreed to renew with the original terms of the contract. Schools have used these vendors for numerous events and programs. We recommend renewing the contract with ABBA Promotions, Bill Heath's Family Sports, BSN Sports, Central Screen Printing, Color Connection, Colonel Connection, Elite Screen Printing, Grandy Ink Spirit Wear, M & M Creations, MoJo Sports, Moonlight Printing Company, Neff Motivations, Pamco, and Uniforms Manufacturing Inc. Far From Boring.com did not agree to renew for the original terms. They will no longer be an approved vendor. We recommend renewing with the fourteen vendors for another year.

# Workman's Compensation Insurance Bid #13-17-5-12

The current contract for Workman's Compensation Insurance is due to expire December 31, 2019. EM Ford has agreed to renew the original contract terms and conditions. EM Ford Insurance has served Henderson County Schools for many years. EM Ford has worked to give us the best coverage at the best price.
