1st quarter update

Last year there were 18 restraints through the 1st quarter. So far this year there have been 2 restraints.

Last year there were 4 suspensions through the 1st quarter. So far this year there have been 3.

Last year through the 1st quarter there were 5 special education students with 3 or more referrals, and 3 more with 2 referrals. This year there is 1 special education student with 3 or more referrals and 2 more with 2 referrals.

SES has a total of 17 referrals so far this school year, which is .07 referrals per day per 100 students.

1st quarter update

Last year LES had 13 referrals through the 1st quarter, this year there are 10 referrals through the 1st quarter.

Last year LES had 3 referrals for fighting/physical aggression through the 1st quarter. This year there have been 4 referrals for fighting/physical aggression.

LES has had .06 referrals per day per 100 students.

Last year there were 3 bus referrals through the 1st quarter. So far this year there have been 2 bus referrals.

FSMS goals

1st quarter update

FSMS has had 66 referrals so far this year. This is .26 referrals per day per 100 students. (last year through the 1st quarter FSMS had 150 referrals)

FSMS has had 11 suspensions so far this year, compared to 6 through the 1st quarter last year. (FSMS finished the year with 95 suspension events last year)

Currently FSMS has 3 students with 3 or more referrals. Last year through the 1st quarter 14 students had 3 or more referrals.

Currently FSMS has 1 special education student with 3 or more referrals. Last year through the 1st quarter FSMS had 7 special education students with 3 or more referrals.

1st quarter update

FSHS has had 97 referrals through the 1st quarter, which is .35 referrals per day per 100 students.

FSHS has had 12 suspensions through the 1st quarter of the school year compared to 17 suspensions through the 1st quarter of last year.

So far this year FSHS has had 4 students with 3 or more referrals. Through the 1st quarter of last year FSHS had 15 students with 3 or more referrals.

Last year FSHS had 2 referrals for vaping through the 1st quarter. Through the 1st quarter of this school year FSHS has had 4 referrals for vaping.
