- Assessing Student Achievement
- i.Data will be presented to this team 6 times per year
- ii.Running records- looking at the beginning of the year compared to the October running records for second grade. 5 at Pre-A in the beginning, but now we have none. We are seeing growth in all levels. Everything is moving up. 11% to 21% on second grade level currently and this is growing. Teachers will turn in running records at the end of November and this data will be presented again in December.
- iii.Running records for first grade show 33 kids at pre-A in the beginning and now they are all at least at an A book. 9% to 17% on first grade level.
- iv.Running records for Kindergarten students are not available yet, but the BAS will be given in December.
- v.SNAP Skills- 1st grades focus skill is backwards counting from 120- They started the year with 5 kids being able to do this and now we have 47 kids. It went from 4% to 41%. We will continue to focus on this skill the remainder of the year. In second grade the focus skill is addition and subtraction using non count by one strategies. We had 13 students in the beginning of the year and now we have 32 kids.

 - Monthly Review- last month Mrs. Morris met with team leads after meeting with Mrs. Jones and discussed what we thought about our school as a whole. Mrs. Morris created the CSIP from the core key concepts we picked.
