Introduction

Christian County School District is soliciting bids from eligible providers participating in Universal Service Fund E-Rate program. The selected vendor will be our primary source for the following:

Products, installation, configuration, and maintenance of a leased lit fiber or leased dark fiber Wide-Area-Network and must be in accordance with Universal Service Fund (hereafter to be called USF or E-Rate).

Vendor Guidelines

Vendors making proposals under this RFP shall be prepared to provide all equipment, materials, labor, and services, not specifically mentioned or shown, which may be necessary to complete or perfect all parts of any installation contract awarded. They shall insure that they are in rules provided by the Universal Service Administrative Company (USAC). To this end, all vendors who present a proposal must meet the following guidelines:

- A. All bidders must have a Service Provider Identification Number (SPIN). This number must be supplied by the bid deadline. Information on obtaining a SPIN is available at http://www.universalservice.org/sl
- B. Any vendor submitting a bid must agree to comply with rules and regulations of the Universal Service Administrative Company. Vendors must be familiar with billing methods and timelines associated with the program, and bid submission of a bid constitutes agreement to all USAC terms. Christian County Public Schools prefers to receive discounted bills.
- C. Bids resulting from this advertisement will be subject to all USAC, FCC, State of Kentucky, and Christian County Public Schools specifications and requirements.
- D. All bids and awards related to this RFP are subject to Christian County Public Schools receiving approval for funding through the E-Rate process. In the event projects are not funded, Christian County Public Schools is under no obligation to select a provider and award a contract and may reject any and all bids if circumstances deem necessary..
- E. Written contracts including a detailed scope of work and project schedule will be required.

Please provide pricing in the form of monthly lease rates for completing, operating, maintaining, and monitoring of the Wide-Area Network components.

Quoted prices must be planned to be effective starting July 1, 2020 and extend through June 30, 2025. Christian County School District retains the right to execute up to (3) five-year contract extensions beyond the initial five-year term.

The successful vendor will be required to participate in the Universal Service Fund and will provide the appropriate discounts if applicable to this project. If Christian County School District does not receive USF funding for the project, Christian County School District may choose not to lease these products and services.

Bid must include a table showing monthly lease costs for the next five years per location. Maintenance costs must be included in the monthly lease costs.

If existing fiber is not used and installation is involved, bidder must break out the on premise equipment costs from the fiber installation costs. Extreme Networks equipment is currently used, and any on premise equipment must connect to the existing equipment.

Format, Due Date

Bids will be opened and acknowledged for receipt at 9:00 a.m., January 6, 2020. Any bids received after said date and time will not be considered; however, no awards will be made until after the review is complete. Contract

The proposal should include a contract for all proposed products and services. If the vendor does not wish to submit an actual contract with the proposal, due to the different alternatives proposed and pending choices from those alternatives (Ex: 1 GBPS and 10GBPS proposals, dark fiber, lit fiber), a sample contract should be submitted with the proposal.

Wide-Area Network Specifications

- 1. WAN must provide a minimum 1Gbps but preferred 10Gbps solution.
- 2. Services must be in place by July 1, 2020.
- 3. If fiber is to be lit, the service provider must activate the fiber or wireless connections in each building, either with transceivers, routers, etc that are dedicated to WAN functions and are included in the overall lease agreement. School District may never own this equipment.
- 4. WAN design with redundancy is preferred.
- 5. All outlying school locations will be connected back to the location of the data center that the school district designates (200 Glass Ave.)
- 6. WAN must be monitored 24/7 for up time.
- 7. Provider will provide on-site service in a link down situation in 4 hours maximum response time.
- 8. School District must be able to pass all standard Ethernet protocols to any point in the network.
- 9. WAN must be capable of passing voice and video traffic as well if the traffic is converted to data.
- 10. If routers are provided, they must be able to pass all Kentucky Educational Technology System (KETS) traffic. Same with transceivers.
- 11. If Christian County School District closes or opens a school location the contract will allow for the addition or subtraction of a school with no penalty to be incurred. If there is a build out of infrastructure needed for a new location not listed, an agreed cost by Christian County Public Schools and the provider will be assessed.
