INSTRUCTIONAL UPDATE: PUBLIC REPORTING K-PREP

Tracey Leath, District Assessment Coordinator, presented a power point presentation and explanation of the 2018-2019 K-PREP test data (a copy of which is attached).

Ms. Leath stated we are still transitioning into a new accountability system, which is not expected to be fully operational until 2019-2020. The Department of Education returned to assigning overall scores based on testing data, which we have not had in several years. Also the Star Rating system is now in affect and directly corresponds with individual schools testing data.

Ms. Leath reviewed the system indicators for the 2018-2019 reporting year, which are: Proficiency, Separate Academic Indicator, Graduation Rate, Transition Readiness and Growth.

INSTRUCTIONAL UPDATE: HIGH SCHOOL GRADUATION REQUIREMENTS

Tracey Leath, District Assessment Coordinator, presented a power point presentation and explanation of High School Graduation Requirements (a copy of which is attached).

Ms. Leath reviewed the minimum high school requirements required to graduate for Class of 2019 through Class of 2021.

LONG-RANGE PLANNING UPDATE

Jack Lackey, School Board Attorney, gave a Long-Range Planning Update in regards to the Nickel Tax Campaign.

He stated "It is easier to spew hate than it is to spread hope." Mr. Lackey stated the opposition for the Nickel Tax has spread hate to Christian County Public School Employees for just simply doing their job. He also stated that the opposition has requested approximately 25 open records request in attempt to show mismanagement of funds or expose conduct that is not in line with Christian County Public Schools employee handbook. Mr. Lackey also stated he has spent most of the day preparing a brief to be filed with the Attorney General's office tomorrow explaining why an employee's personal emails were withheld from an open records request. He apologized to all employees and principals that have been intimidated and harassed.

Mr. Lackey also explained that many of the purchase orders that are under scrutiny by the opposition where fully funded by grant funds.

Mr. Lackey urged everyone to vote for the Nickel Tax on November 5.

COMMITTEE REPORTS

Mr. Moore said there is a plan in place for PBIS and you can tell by the awards handed out tonight. There are four Gold schools this year and only one last year. The targets that were put in place at the beginning of the year, they are hoping to beat by the end of the year. Mr. Moore put some statistics out there that our grandparents reached maturity at age 15, now data shows that maturity is reached at age 28. Teachers are having to take time out of their learning environments to deal with discipline issues. Mr. Moore applauds Ms. Stevenson for the PBIS team she has put together and they are tackling these issues and dealing with them properly.

Mr. Bell mentioned that he doesn't have a committee report but he is looking forward to great opportunities with Service Excellence in the future.

Ms. Hayes hopes everyone that is going online to correct false information, please continue. Everything we do is public record and we are audited every year, with no issues. Please continue to speak the truth.

Mr. Clark stated he spoke with Senator Westerfield who said there is a lot of talk among his peers that there will be additional funding for Senate 1 in the next budget.

Ms. Keller stated the Calendar Committee will hold its first meeting on October 28 and begin to put together the 2020-2021 school calendar.

INDIVIDUAL BOARD MEMBER AND SUPERINTENDENT COMMENTS

MR. BELL

Mr. Bell stated next week is safety week and you will see a lot of information coming out about that. Safety should be at the forefront every day at CCPS. Next week will be centered primarily around anti-bullying and he is proud to announce that Christian County is a green school system in that we have over 1000 people who have taken the pledge to not bully. Mr. Bell also stated "lies have legs, but the truth will stand." He doesn't chase down lies, but he does all he can do to help. He has radio ads, nickel support signs, attends nickel tax meetings and will vote for the Nickel on November 5th because he believes in our kids. If you don't stand for something, you will fall for anything.

MS. HAYES

Ms. Hayes stated that she received a phone call from a concerned parent that they could not reach their child's school. Mr. Jason Wilson, District Technology Coordinator, came to the front and explained to board members the exact trouble CCPS is having with the telephone system. Ms. Hayes also stated that none of us volunteered to be a school board member – we were elected by our peers in an election. There is not many things board members can do but one is to oversee money and make sure it is spent properly. Ms. Hayes questions why they elected her, if they don't trust her.

She mentioned teachers and students are also walking neighborhoods in the afternoons. Every vote will make a difference! We want our kids to know they are valued and want them to stay in Hopkinsville and grow our community.

MS. GEMMILL

Ms. Gemmill wants everyone to know how much she appreciates their hard work and a special thanks to Mr. Lackey for taking the lead and working around the clock. Ms. Gemmill is committed to do whatever she can to help. She mentioned this line "A child is God's gift to you and how they turn out is your gift back." Ms. Gemmill believes the community will be giving the ultimate gift for the future of Christian County. This is why she is in public education and why she has stayed in public education. She said if we don't win, we have tried and we do stand for something.
