Zip scooters is a local electric scooter sharing company owned and operated by Danny Harris/Harris Technology LLC located at 1729 Shopes Creek Rd, Ashland, Ky. Harris Technology LLC is an established company founded in 2004 which distributes industrial reliability equipment for a European company across the USA and other parts of the world.

The basic business model is a fleet of heavy duty electric kick scooters which can be rented by the minute which cost \$1.00 to activate and just .15 cents a minute.

The ZIP scooter app can be downloaded on your phone at the app store or Google play. With the app after entering some information you can locate the scooter nearest to you. After scanning the code on the scooter with your phone camera it unlocks the scooter and you are ready to ride. When you are finished with your ride and parked at a designated geo-parking area the scooter is locked and ready for the next rider. The rider can leave feedback through the app or call if help is needed. The scooters operate at a safe speed of about 15 miles per hour.

- ★ Rider must wear a properly fitted and fastened helmet when operating the scooter.
- ★ Rider is at least 18 years of age and has a valid driver's license.

- ★ Rider agrees not to operate the scooter while under the influence of any alcohol, drugs, medication, or other substance that may impair your ability to operate the Ride GOAT Scooter safely.
- ★ The Scooter must be locked via app at the conclusion of the ride, and parked upright at a lawful parking spot. Geo fencing helps facilitate locations.
- ★ Rider agrees not to carry any heavy or abnormally large carry-on, second person or child on a Scooter. There are weight restrictions noted on scooters.
- ★ Rider is solely and fully responsible for the safe operation of scooter at all times.
- ★ Rider will follow local rules and regulations pertaining to operating an electric scooter
