PURCHASER AGREES TO FURNISH AT HIS OR HER OWN EXPENSE ALL THAT IS NECESSARY FOR THE PROPER PRESENTATION OF THE PERFORMANCE HEREIN, INCLUDING: A SUITABLE VENUE, WELL-HEATED, LIGHTED, CLEAN AND IN GOOD ORDER, FIRST-CLASS PA SYSTEM IN PERFECT WORKING CONDITION, ALL STAGEHANDS, ELECTRICIANS AND ANY OTHER LABOR AS SHALL BE NECESSARY AND / OR REQUIRED BY ANY NATIONAL OR LOCAL UNION(S) TO LOAD-IN, HANG, WORK AND LOAD-OUT THE PRESENTATION; ALL CONCERT LIGHTING, SECURITY, TICKETS, TICKET SELLERS FOR ADVANCE OR DAY-OF-SHOW SALES, TICKET TAKERS, APPROPRIATE AND SUFFICIENT ADVERTISING AND PUBLICITY, INCLUDING BUT NOT LIMITED TO POSTING OF FLYERS AND DISPLAY NEWSPAPER ADVERTISING IN PRINCIPAL NEWSPAPERS. PURCHASER AGREES TO PAY AMUSEMENT TAXES AND ASCAP / BMI PERFORMING RIGHTS FEES AS REQUIRED BY FEDERAL, STATE, COUNTY OR CITY STATUTE. PURCHASER IS RESPONSIBLE FOR OBTAINING ALL NECESSARY LEGAL PERMITS AND / OR DOCUMENTS REQUIRED FOR EMPLOYMENT OF THE ARTIST(S) PRIOR TO ENGAGEMENT. A REPRESENTATIVE OF THE PURCHASER MUST BE PRESENT AND AVAILABLE FROM LOAD-IN THROUGH LOAD-OUT.
- AZ. ARTIST SHALL HAVE SOLE AND EXCLUSIVE CONTROL OVER THE PRODUCTION AND PERFORMANCE OF THE ENGAGEMENT HEREUNDER, INCLUDING, BUT NOT LIMITED TO, THE DETAILS, MEANS AND METHODS OF THE PERFORMANCES OF THE PERFORMING ARTISTS HEREUNDER. ARTIST SHALL HAVE THE RIGHT TO DESIGNATE AND CHANGE THE PERFORMING PERSONNEL. NOTHING HEREIN CONTAINED SHALL BE CONSTRUED AS TO CONSTITUTE THE PARTIES HEREIN (ARTIST AND PURCHASER) AS A PARTNERSHIP OR JOINT VENTURE. THE PERSON EXECUTING THIS AGREEMENT ON PURCHASER'S BEHALF WARRANTS HIS OR HER AUTHORITY TO DO SO, AND SUCH PERSON HEREBY PERSONALLY ASSUMES LIABILITY FOR FULL PAYMENT TO ARTIST.
- A3. IN THE EVENT THAT PAYMENT TO ARTIST SHALL BE BASED IN WHOLE OR IN PART ON RECEIPTS OF THE PERFORMANCE HEREUNDER: (A) PURCHASER AGREES TO DELIVER TO ARTIST A CERTIFIED STATEMENT OF THE ENGAGEMENT'S GROSS RECEIPTS WITHIN ONE HOUR FOLLOWING SUCH PERFORMANCE; (B) ARTIST SHALL HAVE THE RIGHT TO HAVE A REPRESENTATIVE PRESENT IN THE BOX OFFICE AT ALL TIMES AND SUCH REPRESENTATIVE SHALL HAVE THE RIGHT TO EXAMINE BOX OFFICE RECORDS OF PURCHASER RELATING TO RECEIPTS OF THIS ENGAGEMENT ONLY; AND (C) ARTIST SHALL HAVE THE SOLE AND EXCLUSIVE RIGHT TO SET A LIMIT ON THE NUMBER OF COMPLIMENTARY ADMISSIONS PERMISSIBLE FOR THE ENGAGEMENT, INCLUDING BUT NOT LIMITED TO GUESTS OF THE HOUSE, EMPLOYEE GUESTS, PROMOTER GUESTS, GUESTS OF ADDITIONAL PERFORMING ARTISTS, REPRESENTATIVES OF THE PRESS, RADIO, OR ANY OTHER PRINT OR ELECTRONIC MEDIA OUTLETS. PURCHASER SHALL NOT LIMIT ARTIST TO FEWER THAN 20 (TWENTY) GUESTS.
- AG. ARTIST SHALL HAVE THE SOLE AND EXCLUSIVE RIGHT TO SELL SOUVENIR ITEMS AND / OR RECORDINGS BEARING ARTIST'S LIKENESS AND / OR NAME IN CONNECTION WITH, AND AT THE PERFORMANCE HEREUNDER, AND THE RECEIPTS THEREOF SHALL BELONG EXCLUSIVELY TO THE ARTIST.
- AS. THIS CONTRACT MAY BE CANCELED AT THE SOLE DISCRETION OF ARTIST IS UNABLE TO PERFORM BECAUSE OF PROVEN DETENTION BY ACCIDENT, SICKNESS, EXTREME AND DANGEROUS WEATHER CONDITIONS, MEANS OF TRANSPORTATION, OR ANY OTHER SERIOUS LEGITIMATE CONDITION BEYOND ARTIST'S CONTROL.
- A6. THIS CONTRACT MAY BE CANCELED AT THE SOLE DISCRETION OF ARTIST IF THE PERFORMANCE HEREUNDER BECOMES UNCONTROLLABLE, OR ANY DANGEROUS CIRCUMSTANCE EXISTS WHICH MAY THREATEN THE SAFETY OF THE ARTIST, MEMBERS OF HIS OR HER SUPPORT STAFF, OR GUESTS. IN THIS CASE, FULL PAYMENT SHALL BE MADE NOTWITHSTANDING.
- AT. IF ARTIST ELECTS TO PERFORM OR TO CONTINUE TO PERFORM, NOTWITHSTANDING A BREACH OF THIS CONTRACT OR ANY ENCLOSED / ATTACHED RIDER(S) BY PURCHASER, SAID PERFORMANCE SHALL NOT CONSTITUTE A WAIVER OF ANY CLAIM ARTIST MAY HAVE FOR DAMAGES OR ANY OTHER RECOURSE WHICH MIGHT BE OPEN TO ARTIST. PURCHASER SHALL BE RESPONSIBLE FOR FULL PAYMENT IN THE EVENT PURCHASER SHOULD CANCEL THE PERFORMANCE HEREUNDER.
- AS. A MINIMUM 60 (SIXTY) MINUTE SOUND CHECK IS GUARANTEED FOR ALL APPEARANCES. FAILURE TO ACCOMMODATE ARTIST AS TO THIS REQUIREMENT WITHOUT PRIOR CONSENT MAY RESULT IN CANCELLATION OF THE PERFORMANCE HEREUNDER. IN THIS CASE, FULL PAYMENT SHALL BE MADE NOTWITHSTANDING. ARTIST MAY USE THEIR PRODUCTION PERSONNEL FOR MIXING THE SOUND / DIRECTING THE LIGHTING FOR THEIR PERFORMANCE. THESE INDIVIDUALS WILL HAVE ACCESS TO ALL SOUND AND LIGHTING EQUIPMENT USED FOR SAID PERFORMANCE. ANY DELAY IN "START TIME" OF ARTIST'S PERFORMANCE HEREUNDER DUE TO ACTIONS OR PREPAREDNESS OF HOUSE OR THIRD PARTY PERSONNEL SHALL NOT AFFECT FINISHING TIME OR PAYMENT.
- AS. ANY AND ALL ENCLOSED / ATTACHED RIDERS ARE HEREBY MADE IN THEIR ENTIRETY A PART OF THIS CONTRACT. PURCHASER'S FAILURE TO PROVIDE ARTIST WITH THE REQUIRED SOUND REINFORCEMENT MAY, AT THE SOLE DISCRETION OF THE ARTIST, RESULT IN CANCELLATION OF THE ENGAGEMENT. IN THIS CASE, FULL PAYMENT SHALL BE MADE NOTWITHSTANDING.
- NO PORTION OF ARTIST'S PERFORMANCE HEREUNDER SHALL BE RECORDED ON FILM, VIDEO TAPE, AUDIO TAPE OR ANY OTHER MEDIUM, OR SIMULCAST TO THE PUBLIC VIA ANY MEDIUM, EXCEPT BY PRIOR WRITTEN CONSENT OF ARTIST.
- ATT. PURCHASER AGREES TO FURNISH A CLEAN, DRY, WELL-LIT, HEATED OR AIR CONDITIONED, PRIVATE DRESSING ROOM WITH (A) A POWER POINT, (B) SEATING FOR ALL BANDMEMBERS AND CREWMEMBERS, (C) DIRECT, UNOBSTRUCTED STAGE ACCESS, (D) WASHROOMS AND (E) A SHOWER. PURCHASER SHALL KEEP ALL UNAUTHORIZED PERSONS FROM ENTERING SAID AREA (AS WELL AS STAGE AREA AND MIXING LOCATIONS). A KEY TO THE DRESSING ROOM SHALL BE ENTRUSTED TO THE ARTIST'S ROAD MANAGER FROM LOAD-IN THROUGH THE COMPLETION OF LOAD-OUT.
- A12. ALL PAYMENTS ARE TO BE MADE IN FULL IMMEDIATELY FOLLOWING THE PERFORMANCE HEREUNDER UNLESS OTHERWISE AGREED TO BY BOTH PARTIES IN WRITING PRIOR TO THE DATE OF PERFORMANCE. PAYMENTS ARE TO BE MADE BY CORPORATE CHECK, UNIVERSITY CHECK, CASHIER'S CHECK, MONEY ORDER OR CASH (US CURRENCY ONLY). NO OTHER FORMS OF PAYMENT WILL BE ACCEPTED. THE TERM "FULL PAYMENT" WHEN USED THROUGHOUT THIS AGREEMENT IN REFERENCE TO A CANCELED APPEARANCE REFERS TO 100% OF ANY GUARANTEES, OR (66.7% SALABLE CAPACITY MULTIPLIED BY THE MEAN TICKET PRICE) WHEN COMPENSATION TO ARTIST IS CALCULATED SOLELY AS A PERCENTAGE OF GROSS RECEIPTS.


