Purpose of Work Session

- To provide a summary of the current safety proposal
- To get feedback from board members to determine next steps

Purpose of School Safety Officers

- To work closely to build relationships with school staff, students, and community and become part of the JCPS team
- To protect and ensure the safety of students and staff
- To serve schools using the Triad model
- To work with district staff and community partners

Surveys

- 2,573 staff responded to survey sent to all middle and high schools
- Certified, Classified and Administrative staff were surveyed
- 90% responded that they would like an SRO at their school
- Full survey results are provided

Duval Co., FL	129,000	Reports to Superintendent	 Every HS and MS has a least 1 SRO and any school that has more than 2500 students has 2 SROs Each SRO has 2-3 Elementary responsibilities and check in with the principal at those locations every 2-3 days

Naming the Unit and First Steps

School Safety Unit

 Hire an Executive Administrator of School Safety to work side by side with Executive Administrator of Security and Investigations; both report to Chief Operations Officer

Phased Rollout

- Phase 1: Hire School Safety Officers and place in high schools that previously had SROs
- o Phase 2: Officers placed in middle schools that had SROs
- Phase 3: Officers placed in other middle and high schools and assigned to cover elementary schools in area

Training

- State-mandated training for School Resource Officers under Senate Bill 1 (40 hours annually)
- JCPS training (Approximately 60 additional hours annually):
 - o Cross-cultural communication/implicit bias training
 - o De-escalation
 - Restorative practices
 - o Trauma-informed care
 - o Safe crisis management
 - MTSS/PBIS (Multi-Tiered Support Systems and Positive Behavior Intervention and Supports)
 - Students with IDEA/504 protections
 - o Student Support and Behavior Intervention Handbook
 - o Bullying resources
 - New employee training and introduction to the district
 - o Flexibility to add other training as the job develops
