 - ii. 96.5% (55/57) as of 12/13/19
 - iii. 3 students who have fewer credits than required to be seniors that count this year on our 4 year graduation rate, these students are in credit recovery
 - iv. 5 students transfer to DHS as seniors; 3 of these are not academic or career ready
