



1. Purpose:

To raise awareness of and provide access to education on mental health and mental illness for Woodland Middle School (WMS) students and their extended families. In this scenario, mental health education is defined as education regarding behavioral health issues caused by stress, depression, anxiety, relationship problems, grief, addiction, ADHD, eating disorders, learning disabilities, mood disorders, or other psychological concerns.

2. Goals and Objectives:

To increase mental health and mental illness knowledge at the student, educator, and caregiver level through:

- Encouraging participation of students, parents and community members in the Cincinnati Warrior Run (CWR) and related activities.
- Applying funds raised through the CWR toward mental health programming within Woodland Middle School.

To establish annual and longer-term objectives for WMS programming, CWR event participation and CWR funds raised.

3. Collaborating Organizations, including current name/title of representative:

- 1N5: Nancy Eigel-Miller, Executive Director
- WMS: Christi Jefferds, Principal

4. Funding Usage

The intended purpose of this funding is to offer mental health programming focused on promotion, prevention, and early identification. Counseling services for individual student is not an appropriate use of these funds. All programs offered must be evidence-based, and WMS should make it's best effort to offering programming to all students.

- Funds may not be used to support previously existing district programs, surveys or initiatives unless approved in writing by 1N5.
- Funds may not be used to fund programs of other initiatives



- Prior to program rollout email consent from 1N5 must be obtained. Included in this email, WMS should provide any expected outcomes and how these will be tracked. 1N5 staff is available to help think through this process and co-create a plan.

5. Funding Reporting

- Reports are due on a bi-annual basis; by May 1, 2020 and November 2, 2020.
- Reports should document the following:
 1. How the funds were used, including a detailed expense report for the projects or programs supported by 1N5
 2. Additional sources of funding
 3. An evaluation of the projects or programs progress including the number of students served and the outcomes obtained.
 4. Future plans for the project or programs
 5. Any major changes in leadership or direction of the organization

In addition, WMS agrees to notify 1N5 of any conditions or situations that result in a change of plans from the purpose for which this grant was given.

Grant recipients who wish to publicly acknowledge a specific grant or name the foundation as a contributor may do so as long as the attribution is listed as: **1N5**. We ask WMS to send 1N5 a copy of any materials in which 1N5 is listed.

By signing below, you, on behalf of yourself, the organization named above, and all affiliates, heirs, and assigns thereof, acknowledge and agree that (i) receipt of this grant in no way guarantees that grants will be provided in the future, and (ii) that 1N5, its shareholders, directors, and affiliates shall not be held liable for any damages, costs, or fees of any kind or amount relating directly or indirectly from this agreement or this grant.
