The Office of Teaching and Learning (OTL) provides support to schools and districts with an emphasis on highly effective teaching and learning to include responsibility for assisting educators with the implementation of the *Kentucky Academic Standards* (KAS) and a standards-aligned curriculum development and review process. The office facilitates professional learning focused on standards implementation and evidence-based instructional practices related to scaling highly effective teaching, learning and assessment practices. Additionally, the OTL oversees several grants that support improved instructional practices and content knowledge as well as quality professional learning. By providing positive consultative support, collaborating with principals, and improving the application process, the office educates districts on utilizing the Title II, Part A federal grant in ways that best support teacher and principal growth, effectiveness and retention. The OTL further supports schools and districts by providing guidance on comprehensive school counseling, individual learning plans, advanced programs and minimum high school graduation requirements.

- Facilitates and supports the development/revision and implementation of rigorous K-12 academic standards in reading and writing, mathematics, science, social studies, health, physical education, visual and performing arts, and world languages.

- Manages and oversees the implementation of the Read to Achieve (RTA) and Mathematics
 Achievement Fund (MAF) grants, as well as several additional grants that support improved
 instructional practices and content knowledge, including Striving Readers, Professional Learning minigrants and Visual and Performing Arts mini-grants.
- Provides schools and districts with quality service, support and on-site monitoring regarding the use of Title II. Part A funds.
- Assists schools and districts in providing effective comprehensive school counseling services that improve student achievement and support the needs of the whole child.
