Host Organization (hereinafter referred to as "Host Organization")

#### 2. LOGISTICS:

a. Location and hours of operation: It is hereby agreed between the parties to position, operate, and display the Exhibition at the following location(s), date(s), and time(s). Once the agreement is signed, the hours of operation will not be changed without written agreement.

**Transportation:** KHS agrees to transport the HistoryMobile to and from the location listed in part 2(a) above.

- b. Space Requirements: Host Organization agrees to provide a paved, level surface for the HistoryMobile measuring 80 feet by 20 feet with 14 feet overhead clearance.
- c. Exhibition Set-up and Electrical Requirements: An onboard generator will be used to power the HistoryMobile. For visits over three days, hard wiring is necessary. In this case, the Host Organization agrees to provide a licensed, insured electrician at the Host Organization's expense, to connect and disconnect the electricity for the HistoryMobile, which requires a 208/220-volt, 60-amp, single-phase electrical source. KHS staff will conduct all additional duties to set-up the HistoryMobile Exhibition for public access.

## 3. EXHIBITION FEE AND DEPOSIT:

Host organization agrees to pay an exhibition fee of **\$0** to KHS



(payable to "Kentucky Historical Society").

Host Organization agrees to pay the exhibition fee to KHS (payable to "Kentucky Historical Society") due upon the signing of this agreement. The signed agreement and fee are due 30 days prior to the scheduled exhibition of the HistoryMobile. Fee may be non-refundable according to the cancellation schedule in Section 10 of this agreement.

#### 4. EXHIBITION ENTRANCE FEES:

No fees can be charged to HistoryMobile visitors.

#### 5. PERMITS:

The Parties hereby agree that the Host Organization is responsible for obtaining all special event permits and paying any fees that may be required by city, state, or local officials in preparation for the Exhibition.

#### 6. MARKETING AND PUBLICITY:

Host Organization must use the following credit line on all promotions for the HistoryMobile Exhibition:

"100 Years of Kentucky High School Basketball," is a HistoryMobile exhibition developed by the Kentucky Historical Society and in coordination with the Kentucky High School Basketball Hall of Fame. Visit us online at <a href="https://www.history.ky.gov">www.history.ky.gov</a>, and <a href="https://www.history.ky.gov">khshhf.com</a>."

#### 7. STAFFING THE HISTORYMOBILE:

KHS will provide staff to monitor the visitor experience for the hours of operation listed in Section 2 of this agreement. On-site volunteers provided by the Host Organization are encouraged to engage visitor and faculty interaction.

#### 8. MERCHANDISE SALES:

KHS reserves the right to conduct merchandise sales and place additional advertisements within and around the HistoryMobile Exhibition space as listed in part 2(c) of this agreement. KHS reserves the right to retain all proceeds from the sale of any merchandise.

#### 9. CANCELLATION:

<u>Cancellation by Host Organization:</u> Host Organization must promptly notify KHS in writing of any need to cancel this contract. Upon cancellation, Host Organization shall be responsible for an amount equal to the following schedule:

- If notice of cancellation is received more than 30 days prior to the scheduled exhibition
  of the HistoryMobile, Host Organization is entitled to full reimbursement of the fee as
  recorded in Section 3 of this contract.
- If notice of cancellation is received less than 30 days prior to the scheduled exhibition of the HistoryMobile, Host Organization must forfeit the entire fee as described in Section 3 of this contract.

Cancellation by KHS: KHS reserves the right to cancel a booking at any time if host organization breaches the terms of this agreement. KHS reserves the right to cancel any



and all HistoryMobile exhibitions at any time at its sole discretion. In the event that KHS initiates cancellation of a HistoryMobile booking, KHS shall not be held responsible for any costs incurred by host organization in preparation for the exhibition or lost income in the event the booking is cancelled (in whole or in part).

<u>Cancellation due to Weather</u>: If the Host Organization's event is cancelled or postponed due to adverse weather advise KHS by phone immediately. KHS will try to reschedule the HistoryMobile if the game is rescheduled, but cannot guarantee attendance. KHS will cancel the HistoryMobile due to adverse weather if it is unsafe to travel to the site.

#### 10. LIABILITY:

Host Organization agrees to obtain and maintain in full force and effect commercial and general liability insurance for bodily injury and property damage, in an amount not less than Two Million Dollars (\$2,000,000.00). An umbrella policy is sufficient to meet these limits. Coverage shall include premises operations liability, personal injury and advertising liability, independent contractor's liability, contractual liability, and products and completed operations liability. Coverage shall be in effect from the time the Host Organization receives the Exhibition until it leaves the Host Organization's institution. Such insurance shall cover all persons including employees, independent contractors, KHS exhibit representatives, and visitors to the Exhibition at the Host Organization's institution. Any deductible in connection with claims under such insurance must be paid by the Host Organization.

The insurance must also provide (i) that the insurer will not cancel the insured's coverage without thirty (30) days prior written notice to KHS; (ii) that the Commonwealth of Kentucky and/or KHS is named as an additional insured on the policy; (iii) that KHS will not be responsible for any premiums or assessments on the policy and (iv) that a waiver of subrogation applies in favor of KHS. The Host Organization must send KHS a certificate of liability insurance verifying the above coverage before the Exhibition is received.

Proof of insurance must be provided to KHS at least five (5) days in advance. Contact KHS with any questions.

#### 11. JURISDICTION:

The Parties hereby agree that this agreement has been executed under and shall be governed in accordance with the laws of the Commonwealth of Kentucky. The parties hereto agree that any legal action which is brought on the basis of said agreement shall be filed with the Franklin County Circuit Court of the Commonwealth of Kentucky.

12. INDEMNIFICATION: To the extent allowable by law, the host Organization agrees to hold harmless the Commonwealth of Kentucky, the Kentucky Historical Society, and their agents, officers, and employees from any and all claims, demands, damages, actions, and costs to which the Host Organization or the Kentucky Historical Society may have to pay, by reason of injury to any person or property, or loss of life or property, resulting from or in any way connected with the Host Organization's agreement to this agreement, an activity, condition or event arising out of the performance of this agreement, preparation for performance, and nonperformance of any provision of this agreement.



Likewise, and notwithstanding any other provision of this agreement, any and all liability claims against the Commonwealth of Kentucky or KHS shall be brought in accordance with KRS chapter 49A. No clause or part of this Agreement shall constitute, either directly or indirectly, a waiver of sovereign immunity granted under Kentucky Constitution, Section 231 and the United States Constitution, Eleventh Amendment.
