Discussion: Mrs. Marganna Stanley stated the following:

"Our mid-year conversation and review went earlier this evening. I spent time highlighting the work of HCS+ Building Better Graduates, authentic learning, digital backpack, facility upgrades, school safety initiatives, STEAM/STEM integration in media centers, academic focus on reading and writing, collaboration, and our core values.

Our vision with our strategic plan (when it was written in 2015) was to move from a great school district to a world-class school district preparing our students for the social and academic issues that challenge them every day and for the competitive world they enter after graduation. We are well on that trajectory to success.

The working budget that will be presented tonight has significantly changed throughout the last six years, moving from a 7.1 million dollar reduction (2013-2014) and another 4 million dollar reduction the following year to now a contingency at 7%. As I reflect on the work over the last six months it mirrors the last six years. Setting goals and working hard to achieve them. Finding solutions, finding the YES!, removing barriers for our students, having tough and fierce conversations when needed, and celebrating when appropriate. We have accomplished so much through the work of teachers, administrators, our staff, and our students!

As we start developing a new five year strategic plan, I believe it is now the best time for our board to select a new leader that will carry that work forward.

Contributing to the district the past six years as the Superintendent has been rewarding both personally and professionally. I am humbled and grateful for a 30 year career in the Henderson County Schools.

Tonight I publically announce my retirement effective June 30th. I wish the board the very best as they begin a search for a new superintendent. I am committed to a smooth transition. And will continue working with the board to ensure that.

I want to thank our school board members for your trust, your leadership, and your support. Many, many people have helped me, coached me, and empowered me. That

support has allowed me to lead collaboratively and serve our students, staff, and community with integrity and excellence. My heart and soul are filled with pride and my hope is that the Henderson County Schools thrive to expand horizons for our students. Thank you."
