**Fees:** (Renter agrees to pay the BCPWAA the total Sum of): \$2500 annual fee for girls soccer and \$2500  
annual fee for boys soccer.

1. **Insurance and Indemnity.** The Renter agrees to maintain through the Event liability insurance in  
the amount of \$500,000.00. The Renter shall obtain and furnish a certificate of liability  
insurance seven days prior to the Event naming the Boone County Pee Wee Athletic Association  
as an additional insured. The Renter agrees to reimburse the BCPWAA for any injury or damage  
to any participant in the Event or the property of the Renter or any participant arising from any  
cause other than the gross negligence of the BCPWAA. The Renter agrees to defend, indemnify  
and hold the BCPWAA harmless from any claim arising from any injury or damage caused to any  
person or property at the BCPWAA due to the acts or omissions of the Renter or its participants  
that occurs at the BCPWAA.

2. **Medical Treatment of Minors.** The Renter must obtain and keep on file for all participants who are minors forms consenting to emergency medical treatment properly executed by a parent or guardian. Each such form must contain the name, address, emergency phone number, medical insurance information and copy of medical insurance card for each participant who is a minor.
3. **Supervision.** The Renter shall provide counselors for supervision of minors who are participants. The BCPWAA shall determine, in the exercise of its sole discretion, the number of counselors required for the Event based on the nature of the Event and the number and age of the minor participants. This list must be forwarded to the conference coordinator seven (7) days in advance of the group's arrival at the facility.
4. **Serving of Alcohol.** The Renter **WILL NOT** serve or allow consumption of alcoholic beverages. Violation of this clause shall be grounds for termination of the contract.
5. **Use of BCPWAA Name or Likeness.** Boone County Pee Wee Athletic Association reserves the right to review and approve ANY utilization of the name or visual representation of the BCPWAA prior to use. This includes any and all print and/ or electronic production or publication and use and placement of signage on the BCPWAA property. Violation of this clause shall be grounds for termination of the contract.
6. **Miscellaneous.** This Agreement shall be governed by the laws of the State of Kentucky. No PETS, No Smoking inside the gated area (smoke in parking lot), No Skateboards or bikes. Please clean up any trash around the turf area and move nets off the turf at the end of the night.
