## Information/Review/Discussion Item:

Consider 2020-2021 School Calendar (2nd Reading).

#### **Applicable Statute or Regulation:**

KRS 158.060, KRS 158.070, and 704 KAR 7:125 (board to adopt a school calendar for the upcoming school year on or before May 15).

#### Fiscal/Budgetary Impact:

Loss of funding is possible if legal standards are not met for attendance requirements.

#### History/Background:

The calendar committee met on January 9 to develop the school calendar for the 2020-2021 school year.

#### Talking points of the proposed calendar:

- First day for students is Wednesday, August 19.
- Spring Break is scheduled for March 31, April 1, 2.
- Last scheduled day for students is Tuesday, 5/25 and closing for teachers on Wednesday, 5/26.
- The testing window for 2020-2021 is the last two weeks of school.
- Calendar includes 177 days, 7 days would be banked, 10 NTI Days.
- 240 day staff will have two additional holidays, Friday, July 3, 2020 and Monday, May 31, 2021.
- We could miss 20 days and still get out in May. Our ten year average is 19.6
- First day for Early Childhood (Headstart and Pre-school) will be Monday, August 24. Early Childhood will be in session on the following Fridays: September 11, October 9, October 30, November 6, December 18, January 21, and March 5.

Approve 2020-2021 school calendar.
