Consider/Approve letter to Interim Commissioner Brown requesting a waiver from 701 KAR 8:020, Section 3(4) pertaining to mandated school board training on charter topics until June 30, 2021 or until the board receives a charter application.

HISTORY/BACKGROUND:

Each board member is currently required to receive 12 hours of charter school authorizer training annually. An amendment to 701 KAR 8:020 is under legislative review and if amended would state that board members do not have to receive the training until they receive an application to open a charter school. In light of this, the Kentucky Department of Education will, upon request of the district superintendent, grant a waiver of the required 12 hours of charter school authorizer training until June 30, 2021 or until the board receives a charter application.

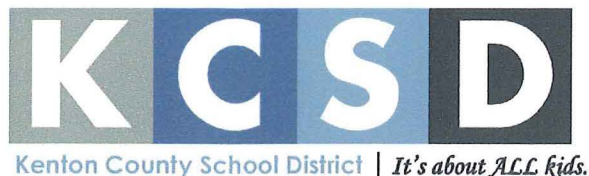
