# Review of Officials Fees for 2020-2021 Per Schedule, Baseball, Softball, Field Hockey, Volleyball

Commissioner Tackett and Associate Commissioner Cope suggested a survey of surrounding states seems to be in order as one has not been done in several years and may shed light on the need for fee changes, which would still allow time for adjustment to schedules and budgets.

Items discussed for consideration were:

- A \$5 increase in baseball and softball would be \$180 per year for 18 varsity home baseball games and \$180 for varsity home softball games (most of which are two person crews).
- The baseball/softball fee has not been adjusted in eight years in these sports that come with significant equipment cost.
- Field Hockey fee is highly competitive with other states.
- Volleyball was increased four years ago with additional matches (full 3 of 5) and a pay scale for other positions in addition to the referee and umpire.

## Football - RPI Review for Possible Revisions (Discuss Out of State Fixed Value)

Commissioner Tackett walked the Board through the out of state value that in most all states, was set to RPI for both OWP and OOWP (.5) when calculating RPI referring to several listings during discussion.

Careful attention was paid to the information containing the total number of unique games used in that team's RPI calculation. This amount demonstrates the minute value of a single game out of state in any calculation. There was however, sentiment that matching the out of state value to the in-state data would be logical.

**Motion Passed:** For football, assign the out of state team value for OWP and OOWP to the average winning percentage of all Kentucky schools for the previous year passed with a motion by Scott Hawkins and a second by Donna Bumps. #### Football - RPI Review for Possible Revisions (Discuss Game Value for Withdrawn Teams)

The Commissioner informed the Board that the withdrawal of Jenkins points to potential issues with the RPI and a decision that needs to be made about teams that withdraw and how they would be considered.

There is a difference when a class 3A team withdraws and was scheduled to play a 2A team than the impact of a 2A team withdrawal that was scheduled to play a 4A team. As such, the variable should be defined.

A clear way to ensure transparency would be that the class of team being compared would be of no factor in that specific game calculation. That being, a 3A team playing an opponent that has withdrawn would get the 3A game factor instead of trying to see where the original class of the withdrawn team was placed.

## Football - RPI Review for Possible Revisions (Discuss Playing Down Exception)

Commissioner Tackett reported that in a few states, each school is allowed one or more exceptions to play down and not have any impact on the RPI calculation. This possibly could lead to schedule manipulation and is normally only done in states with annual revisions in the formula. In most states, the formula is set and not adjusted or only adjusted minimally.

# Football - RPI Review for Possible Revisions (Discuss 35-35-30 and Options for 40, 30, 30 as well as 40, 35, 25)

Commissioner Tackett continued the update in the RPI discussion with the factors involved in the RPI equation, WP (winning percentage), OWP (Opponents winning percentage), and OOWP (Opponent's opponents winning percentage) all as multipliers for the total RPI.

In 2019, the following was adopted for 2019-20 for RPI calculations:

- 1. These three components are combined to produce the RPI using the following formula:
  - a. RPI = (WP \* WPVAL) + (OWP \* OWPVAL) + (OOWP \* OOWPVAL)
- 2. The KHSAA has adopted for its RPI using the following final calculation:
  - a. WPVAL shall be .35 (or 35 percent)
  - b. OWPVAL shall be .35 (or 35 percent)
  - c. OOWPVAL shall be .30 (or 30 percent)

Information showing the impact of such a change was provided.

In some states, the factors have been changed to .4, .3, .3 to highlight the first factor (winning percentage) more, but this appears to penalize those schools that play out of state teams. As pointed out, with 42 counties and 7 states on Kentucky's borders, at least for now, gathering individual game scores of all out of state teams is not feasible.

#### Football - RPI, Three-Way Tiebreaker Use

The modified points system or Dickinson System has been used to break intra-district ties for playoff positions for the past thirty or more years. This system requires, in many cases, intense research and verification to ensure that all out of state records are included and accurate including in many states where this information isn't readily available. Additionally, the seasons from border states do not align, and in many cases, teams could be rewarded or penalized by this lack of alignment of seasons.

The advent of the RPI offers an option that wasn't available before. With its adoption, teams are constantly monitoring the RPI and using its results to break these ties would ensure quick resolution to questions and transparency in the findings.

#### Track and Field Items

#### Track/Cross Country Enrollment Report and Possible Changes

Commissioner Tackett and Assistant Commissioner Bridenbaugh reminded the Board that existing policy states that there will be a mid-course adjustment to the four-year adopted alignments in the classified sports.

After two years, if a school has met two criteria:

- 1. Their current four-year average enrollment would place them in a different class than currently placed and
- 2. Their four-year average enrollment has increased or decreased by 10 percent from the fouryear average that placed them in that class.

Any change would impact the 2020-21 and 2021-22 school years. A complete review and reclassification would be done for the 2022-23 school year to last through the 2025-26 season.

After the two year review, two schools would be required to move into a higher class- Collins and Moore, both from 2A to 3A.

After the two-year review, three schools could move down in class, Fort Campbell (2A to 1A), Harlan County (3A to 2A) and Jeffersontown (3A to 2A). Past practice has been to contact these school designated representatives and offer them that opportunity as it may be that travel or other logistical concerns make it desirable to remain in the original class.

**Motion Passed:** Approve the report and moves up in class as required, direct the Commissioner to contact the three other impacted schools and revise alignment for 2020-21 per responses passed with a motion by Trent Lovett and a second by Jeff Saylor.
