5. ORDINANCES – 2<sup>ND</sup> READING

**5.A.** Ordinance 3-2020 entitled AN ORDINANCE REVISING THE CITY OF OWENSBORO EMPLOYEE HANDBOOK POLICY 109 EMPLOYMENT OF ENTRY-LEVEL POLICE OFFICERS AND FIREFIGHTERS IMPLEMENTING THE EDUCATING HEROES PROGRAM FOR POTENTIAL APPLICANTS FOR THE OWENSBORO POLICE DEPARTMENT, was approved 5-0 on motion of Mayor Watson with a second from Commissioner Smith-Wright.

Technical revision of Policy 109 in the Employee Handbook is necessary for the Police Department to be able to implement the new Educating Heroes program offered by the Kentucky Department of Criminal Justice Training which will provide the opportunity for a new police applicant to earn an Applied Science Associate's Degree from the Kentucky Community and Technical College System, Bluegrass Community and Technical College while he or she is attending law enforcement basic training.

## 7. MUNICIPAL ORDERS

**7.A.** Consider Municipal Order 4-2020 entitled A MUNICIPAL ORDER AUTHORIZING AND DIRECTING THE MAYOR TO EXECUTE AN APPLICATION FOR A KENTUCKY TRANSPORTATION CABINET OFFICE OF HIGHWAY SAFETY GRANT IN THE APPROXIMATE AMOUNT OF \$46,000.00, THE PROCEEDS OF WHICH WILL ENABLE THE OWENSBORO POLICE DEPARTMENT TO PROVIDE OVERTIME TRAFFIC ENFORCEMENT DURING SPECIFIC MOBILIZATIONS WITHIN THE CITY OF OWENSBORO TO ENHANCE PUBLIC SAFETY; NO CASH MATCH BEING REQUIRED BY THE CITY, was approved 5-0 by motion of Mayor Watson and a second by Commissioner Sanford.

The Owensboro Police Department officers provide traffic enforcement during mobilizations in an effort to reduce traffic offenses. The grant funds will directly cover overtime for specific mobilizations. This grant would allow the Owensboro Police Department to enhance public safety through direct enforcement during the "Click It or Ticket", "Speed Weeks" and the "Drive Sober or Get Pulled Over" mobilizations. The estimated costs of overtime and expenses are a total of \$46,000.00. City Manager Pagan explained the MO authorizes a grant application for overtime costs related to traffic enforcements.

**7.B.** Consider Municipal Order 5-2020 entitled A MUNICIPAL ORDER AUTHORIZING THE MAYOR TO EXECUTE A MEMORANDUM OF AGREEMENT WITH AMERICAN HYDROPLANE EVENTS, LLC, PROVIDING FOR A HYDROPLANE RACING EVENT IN OWENSBORO IN 2020, was unanimously approved by motion of Mayor Watson with a second from Commissioner Smith-Wright.

The City has negotiated with American Hydroplane Events, LLC to provide a hydroplane racing event August 14-16, 2020. This order authorizes the agreement and details

thereof. City Manager Pagan further explained that the breakdown of logistics between the City and AHE for the returning hydroplane event.

Chief Howard announced that recruitment is on going for entry-level Firefighters and encouraged interested candidates to apply.

## **9.** COMMUNICATIONS FROM ELECTED OFFICIALS

Commissioner Conder requested Chief Howard explain the purpose of the Knox Box. Chief Howard explained that a Knox Box is a secure box installed on a building that contains an entry key to the building for the Fire Department. Only specific people have access to the box including the Fire Chief, Fire Command staff and front line engine crew. The Owensboro Fire Department keys do not unlock boxes within another area, including the County and vice versa. The benefit of the box is if there is a fire call during non-operational hours of the business, the Fire Department can gain access without destroying property to enter. New businesses and businesses with a change in occupancy are required to install the boxes to have their occupancy activated. The boxes typically range from \$300-\$400 and are an option for residential use as well. The Police Department cannot access the boxes even with a warrant. Some existing businesses that were grandfathered in about fifteen (15) years ago do not have the Annexed businesses will need to get a key to the City fire department. boxes. Additional information and applications can be accessed from the Owensboro Fire Department.
