After 45 days prior, CSC will consider the reservation final and the school/customer will be responsible for full payment of all seats reserved or programs scheduled, no exceptions. If a program is booked within 45 days of the performance date, full payment must be made immediately.

Cancellation: If a show must be cancelled due to inclement weather (including school closing), serious actor illness or other emergency, CSC will make every effort to reschedule the program during the current year as soon as possible. All bookings are non-refundable and non-exchangeable. All plays and dates are subject to change. CSC reserves the right to collect surveys and/or donations from audience members.
