Group Leader Agreement - Code of Conduct

Welcome Group Leader!

Please read and communicate expectations with your students and chaperones ahead of time.

BEHAVIOR GUIDELINES.

Stay Together - Students and chaperones must stay in their assigned 1:5 or 1:10 group for the entire visit and follow the schedule. Students must remain with a chaperone at all times. Children wishing to shop at the museum gift shop or order at the food court need to be escorted by a chaperone.

Stay Safe - Always walk and use an inside voice. Enjoy equipment in a safe way. Respect posted age limits, capacity limits, guardralis or barriers in certain exhibits. All chaperones must wear wrist bands that list prearranged experiences.

Clean Up - Keep food and drink (including gum) only in the permitted areas- all exhibits, including the Omnimax; do not permit food or drink. Smoking is only permitted outside.

Show Respect - To staff, other guests, exhibits, each other and ourselves.

Groups who do not follow Behavior Guidelines may be asked to leave CMC and could have visiting privileges suspended.

PROHIBITED BEHAVIORS

- · Any unlawful acts or behavior
- · Any act that threatens the safety of our guests or staff
- · Any act that threatens the safety of our exhibits or artifacts
- Any act that threatens the well-being of our building and property
- · Any act that is disruptive to other patrons
- Any act that hinders our employees in the performance of their duties
- Any act that is inconsistent with the purpose of this facility, which is to provide for the education of the public
- In accordance with Ohio Revised Code 3794, smoking is prohibited inside the Union Terminal building

EXAMPLES of specific activities that are prohibited include, but are not limited to:

- · The use of profanity, vulgar or threatening language
- The wearing of obscene, vulgar, or indecent clothing that is inconsistent with a family friendly environment
- Animals, other than licensed service animals
- Tampering with any museum display, artifact, artwork, or property not specifically set aside for that purpose
- The use of drugs or alcohol while on museum property, (with the exception of designated events and areas)
