BALLYSHANNON MIDDLE SCHOOL (BG #15-279 / REH #129-1214-A)

Closeout documentation is in process and the BG-4 and BG-5 Contract and Project Closeout forms will be presented for approval at a future meeting.

BOONE COUNTY BUS MAINTENANCE - ADDITION (BG #19-103 / REH #129-918-D)

Punchlists have taken place and any warranty issues will be addressed during the one year period of corrections. Closeout documentation is in process and the BG-4 and BG-5 Contract and Project Closeout forms will be presented for approval at a future meeting.

BOONE COUNTY CENTRAL OFFICE ANNEX (LEARNING SUPPORT SERVICES) - RENOVATIONS (BG #19-104 / REH #129-918-D)

Monarch Construction continues to make good progress. The building pad is complete and the contractor remains on-site doing finish grading. We have decided to move the asphalt paving and concrete sidewalks scope into Phase 2 since Monarch is the successful contractor on both phases. There will be a no-cost net change to move this work and it will allow for a better time of year for installation and less likelihood of damage.

The preliminary Phase 2 schedule has been issued and is in compliance with the District's completion date of June 1, 2021. We continue to make progress and will hold weekly meetings to monitor developments.
